Implementation Status and Key Decisions

The PDO remains relevant and, on its current trajectory, the project is expected to achieve most of its major outputs efficiently within the current project closing date. Progress has been made in implementing project activities during the period, however, the PDO indicators, disbursements, and all but two Intermediate Results Indicators remain behind schedule mainly due to delays in procurement of the FMIS and RMS. The RMS implementation is underway and the FMIS contract was signed on April 11, 2024. To accommodate the schedule for FMIS implementation and operational acceptance of the system, a project extension of five months through August 25, 2025 was approved on April 11, 2024.


