ENVIRONMENTAL AND SOCIAL COMMITMENT PLAN

- 1. The Republic of Sierra Leone (the Recipient) shall implement the State- and Peacebuilding Fund (SPF): Sierra Leone, Innovative Solutions for Land Dispute Resolution Project (the Project), with the involvement of the Ministry of Lands, Housing and Country Planning, as set out in the Financing Agreement. The International Development Association (the Association) has agreed to provide financing for the Project, as set out in the referred agreement.
- 2. The Recipient shall ensure that the Project is carried out in accordance with the Environmental and Social Standards (ESSs) and this Environmental and Social Commitment Plan (ESCP), in a manner acceptable to the Association. The ESCP is a part of the Financing Agreement. Unless otherwise defined in this ESCP, capitalized terms used in this ESCP have the meanings ascribed to them in the referred agreement.
- 3. Without limitation to the foregoing, this ESCP sets out material measures and actions that the Recipient shall carry out or cause to be carried out, including, as applicable, the timeframes of the actions and measures, institutional, staffing, training, monitoring and reporting arrangements, and grievance management. The ESCP also sets out the environmental and social (E&S) instruments that shall be adopted and implemented under the Project, all of which shall be subject to prior consultation and disclosure, consistent with the ESS, and in form and substance, and in a manner acceptable to the Association. Once adopted, said E&S instruments may be revised from time to time with prior written agreement by the Association.
- 4. As agreed by the Association and the Recipient, this ESCP shall be revised from time to time if necessary, during Project implementation, to reflect adaptive management of Project changes and unforeseen circumstances or in response to Project performance. In such circumstances, the Recipient through the Ministry of Lands, Housing and Country Planning and the Association agree to update the ESCP to reflect these changes through an exchange of letters signed between the Association and the Recipient Minister of Lands, Housing and Country Planning of the Ministry of Lands, Housing and Country Planning. The Recipient shall promptly disclose the updated ESCP.

The final responsibility to ensure that the Project is carried out in accordance with the Environmental and Social Standards remains with the Recipient. Maintain the SLLAP PCU with Social Development and Gender Specialist, Community Engagement and Communication Specialist, and Environmental Specialist and ensure support from the SLLAP PCU to FAO for the management of Project E&S risks; Hire specialized external expertise/consultants for Project activities as needed, all with terms of reference, experience, and qualifications acceptable to the Association. Participate in the management of environmental and social risks relating to the scope of the work FAO commits to undertake in the context of the Project, as indicated in the Standard Form Agreement, by complying with the environmental and social requirements and material measures of the ESCP which are listed in Annex VI of the Standard Form Agreement. Hire a social specialist to support the FAO project team in implementing the parts of this ESCP that FAO is responsible for and liaise with the PCU. Develop and submit to the PCU, every quarter (3) months (15 days after the end of each quarter), an environmental and social monitoring report.
