Implementation Status and Key Decisions

Vietnam Solar Transition Accelerator (VISTA) project implementation progress has been delayed due to the uncertain policy and regulatory environment for procurement of new generation capacity. In May 2023 the MOIT and the World Bank agreed in principle to cancel the grant due to lack of remaining implementation time before project closure in March 2025 and regulatory uncertainty. The team is expecting a formal request from the State Bank of Vietnam by end of August 2023.


