1. PROJECT DEVELOPMENT OBJECTIVE

1.1 Development Objective

Original Development Objective (Approved as part of Approval package on 28-Sep-2022)

The Program Development Objective (PDO) is to improve (1) the efficiency of land administration, (2) the regulatory framework for private investment in fiber optic infrastructure, (3) services provided by investment promotion agencies and public-private partnership units, and (4) the efficiency and transparency of government-to-business services in participating states.

3. KEY ISSUES & STATUS

3.1 Implementation Status and Key Decisions

External Borrowing Plan (EBP): The EBP was amended in December 2023 to include SABER.

Disbursement Against Prior Results (PR): The verification of PR by the Independent Verification Agency (IVA) consultants has been completed. Twenty-eight states met the Eligibility Criteria (EC), twenty-two states achieved the PR under DLI1, twenty-two states achieved the PR under DLI4, ten states achieved the PR under DLI5, and twenty-one states achieved the PR under DLI6. In total, twenty-three states are qualified to receive program funds for the PR achievement (total of SDR 52,136,400.00), subject to the signing of the SLAs between the Federal Government of Nigeria and the states. **Deadlines for Year 1 (2023) DLIs and EC have passed.** Sixteen states leveraged Technical Assistance (TA) for DLI1.1; seven states for DLI1.2; twelve states for DLI2; nine states for DLI3; fifteen states for DLI4; thirteen states for DLI5; fifteen states for DLI5; fifteen states for DLI6; ten states for DLI7.1; and twenty-six states for DLI8.



Progress on Year 2 (2024) ECs and DLIs: Deadlines for four of the five Year 2 EC have passed. Thirty-two states have published the 2023 Progress Report by July 31, 2024; thirty-six states published the Annual FY23 audited financial statement by July 31, 2024; thirty-five states published the Annual FY24 state budget by January 31, 2024; and 36 states (and FCT) published the annual State Debt Sustainability Analysis and Debt Management Strategy Report (SDSA-DMSR) by December 31, 2023. The deadline for the preparation, approval and publication of State Business Enabling Reforms Action Plan (BERAP) 2025 is December 31, 2024. TA for DLIs 1.2, 2 and 7 is ongoing and TA for other DLIs is being initiated by the TA providers.


