The Program Development Objective of the Transport Sector Modernization Program (TSMP) is to upgrade transport infrastructure alongpriority transport links and to strengthen capacity for sustainable transport asset management.

The Project Development Objectives of the First Phase of the TSMP (the Federation Road Sector Modernization Project) are to improve road connectivity and safety for road users along project roads and to strengthen capacity for sustainable management of the main road network in the Federation of Bosnia and Herzegovina.

#### Implementation Status and Key Decisions

The major works under Components 1 and 2 are complete or scheduled to be completed by September 30, 2023. The Crnaja tunnel rehabilitation has been completed. The remaining works are related to Stolac entrance, and three other small sections planned for rehabilitation/upgrade. In addition, all the technical assistance activities financed under Component 3 of the project have been completed, except the Engineering design

studies for typical engineering solutions for site-specific vulnerabilities expected to be completed before the current closing date. The disbursement rate as of May 2023 is 92% and the FY disbursement ratio is 64%.

With respect to the **PDO indicators**, there is data confirming that all of them have been met, except for "the vehicle operating costs for heavy vehicles along the Project's sections [EUR/veh-km]", for which data is to be collected at project completion. As requested during the previous mission, Bank approved extension of the loan closing date by 10 months to September 30, 2023, to complete the remaining works and consultancies, and the notice to the Borrower was issued on November 17, 2022.

The Project Annual Report is in process of being developed and will be completed and shared with the Bank by end June 2023.


