#### Implementation Status and Key Decisions

The Project's rating for progress towards achievement of the Project Development Objective is upgraded from "Moderately Unsatisfactory" to "Moderately Satisfactory," and the rating for implementation progress is upgraded from "Moderately Unsatisfactory" to "Moderately Satisfactory." Despite previous significant delays, there has been notable progress in both these areas after three years without implementation progress, including no procurement. These include completion of the Project Management Unit's procurement for two individual consultants to support eservice delivery, and the launch of procurement for two large investment activities to upgrade the government's national portal, and the whole-ofgovernment integration platform. There is significant work expected to develop and finalize the technical specifications and procurement documents for the remaining project activities to be procured over the next three to six months; and bid evaluation processes, contract management, and quality assurance for the two large activities currently under procurement. During the Bank's October 2023 mission, the government teams agreed to strengthen the project coordination arrangements as project implementation intensifies in the coming 18 months before the project closes.


