Implementation Status and Key Decisions

The project has continued to make sustained progress across all components towards achieving its Development Objective. Major results milestones have been achieved on food safety, enhancing market access and sustainable land management activities. As such, the project continues to be rated *Satisfactory* for its prospects of achieving the PDO.



The GoM, through its pertinent institutions has provided timely and effective support to the implementation of the baseline MACP activities, and more recently the preparation of the GEF AF. This was done against a backdrop of a complicated COVID-19 epidemiological situation, under conditions of physical distancing and lockdowns of varying degrees imposed by the authorities.

The project's financial management, procurement, safeguards, and citizens engagement arrangements remain satisfactory. The project is compliant with financial reporting and auditing requirements and there are no overdue audits or any other outstanding financial management issues. The remaining procurement packages and activities are on track to be completed in line with the project's current implementation timeline. The project's safeguards arrangements are compliant with the World Bank requirements and safeguards performance remains *Satisfactory*. Disbursement estimates for FY22 stand at US\$2.0 million.

The Project continues to respond properly to its citizens engagement commitments. A grievance resolution mechanism has been established in 2015 and is being updated in 2021 to correspond to additional rigors related to the implementation of the animal by-products management activities. There have not been any complaints filed under the mechanism in the past 24 months. The team will continue to work intently over the remaining implementation period on further promoting citizen engagement strategies and reporting, in close collaboration with dedicated citizen engagement specialists.




