***INDIA: National Cyclone Risk Mitigation Project - II  
Credit Number 5693-IN  
Partial Cancellation***

We refer to the Financing Agreement between India (“Recipient”) and the International Development Association (“Association”), dated August 11, 2015 (“Financing Agreement”), and to the Project Agreements between the Association and each of the State of Goa, the State of Gujarat, the State of Karnataka, the State of Kerala, the State of Maharashtra, and the State of West Bengal, respectively, of the same date (collectively, “Project Agreements”), pursuant to which the Association has extended the above captioned credit (the “Credit”) for the National Cyclone Risk Mitigation Project - II (the “Project”).

We also refer to the letter No.12/3/2018-FB.V dated March 13, 2023, from the Department of Economic Affairs, Ministry of Finance, requesting the partial cancellation of fifteen million United States Dollars (USD 15,000,000) of the Credit.

In view of the foregoing and in accordance with the provision of Section 6.01 of the “*International Development Association General Conditions for Credits and Grants*”, dated July 31, 2010, as modified and applicable to the Financing Agreement, the Association hereby cancels, as of March 13, 2023, the amount of fifteen million United States Dollars (USD 15,000,000) of the Credit. The withdrawal table set forth in Section IV.A.2 of Schedule 2 to the Financing Agreement has been revised accordingly and the revised withdrawal table is attached to this letter as Annexure I.

The commitment charges on the total amount cancelled cease to accrue from March 13, 2023.
