The proposed project Kenya Informal Settlements Improvement Project 2 [KISIP 2 (P167814)] is similar to Kenya Informal Settlements Improvement Project [(KISIP 1) P113542 US\$ 165 Million, approved on March 24, 2011 and closes on November 30, 2019] will support the interventions that have been successful under KISIP 1: tenure regularization, infrastructure upgrading, and institutional strengthening.

Procurement Profile: The procurement activities are not complex, however small value and number of activities at decentralized level can pose a challenge. The procurement profile is mainly construction of roads, drains, water supply and sanitation interventions, and supply & installation of high mast lamps in the identified informal settlements. Also, the project requires consultancies for preparation of the integrated settlement report/plan and for supervision. The project requires additional consultancies based on the specific requirements in each component.

In view of the challenges in identifying the requirements from the informal settlements and to ensure the belongingness & sustainability of the assets created through the project, the consultant will be hired to carry out the participatory analysis in collaboration with Settlement Executive Committee (SEC) and the other stakeholders to arrive at the requirements at each settlement. The KISIP 2 will support investments in infrastructure and services in about 50–56 settlements in urban areas. KISIP 1 has financed the preparation of detailed designs and bidding documents for upgrading plans for 39 settlements in six counties (Nairobi, Kilifi, Kakamega, Kisumu, Nakuru, Mombasa).

The strategy of preparation of remaining detailed implementation plans may be combining the design and supervision as integrated package as discussed.

Implementation of the plans will ensure that KISIP 2 is able to provide relatively quick and high-impact results. Implementation of these plans is expected to absorb about US\$70 million. The remaining US\$30 million of project funds for infrastructure can cover an additional 17–20 settlements in other counties based on the clear criteria.

The average size of the integrated settlement plan per each informal settlement is US \$ xxx (to be determined) million. The project intends to take up 20 settlements in Planning and Survey and 30 Settlements for Preparation of Engineering Designs settlements in phase 1 based on the readiness of integrated settlement plans. The nature of these scattered works and small Goods like installation of High mast lamp. Based on the learning from the KISIP 1, the project team deliberated and intends to approach the Design and Supervision as combined procured transaction. This approach may reduce the time and efforts of design review by supervision consultant and minimize the variations the implementation.

Trainings/ Capacity Development initiatives through the project will not be a Procurement Transaction unless a service provider (consultant) is exclusively hired from the market through an agreed procurement method of selection of Consultancies. If there is no price discovery and the fund is transferred to the communities or to the counties, then these transactions will not part of the procurement plan for first 18 months.

Operational Expenses: Includes office space rental and utilities; office maintenance and repair; office consumables; rental of vehicles; operation and maintenance; communication; printing and/or publication expenses; staff per diems; field allowances; travel expenses; bank charges; insurance premium; and extraneous allowances for the staff are not envisaged through the procurement plan. The project may follow its own established administrative procedure through national procurement arrangements.

Governance aspects

Kenya is having population of 48 Million (Est 2018) and having geographical area of 580,367 Sq km, situated in the East of Africa bordering Somalia to the East,

Uganda to the West, Ethiopia to the North and Tanzania to the South. It gained independence in 1963. A major milestone in the political context of Kenya is the founding of the new constitution in 2010. The 2010 constitution provides for two autonomous but interdependent levels of government: national and 47 county governments with mainly elected assemblies, elected governors, and governor-appointed cabinet members ratified by the assembly. The constitution eliminated the previous third tier of government, the urban and rural local authorities, and transferred their revenues and functions to the county governments. With a guaranteed unconditional transfer of national revenue, called the 'equitable share,' the county governments are expected to address local needs for devolved services, including urban infrastructure and services. The Counties are now responsible for investment in urban infrastructure and services, housing, public parks, and the like.

Conclusion and associated Procurement Risk(s): In spite of recent tension faced during the elections in 2017 and terrorist attacks, Kenya has been placed in the forefront of African countries to have a major role in putting Africa on the world map in terms of economic prosperity and political stability. The informal settlements spread across all 47 counties. In terms of project's supervision by both the project functionaries and Bank's team, challenge to access and ensure effective supervision in few counties. These counties will be identified upfront, categorised and appropriate procurement approach will be tailored to sensitive counties.

Economic Aspects

Kenya is the economic, financial, and transport hub of East Africa. Kenya's real GDP growth has averaged over 5% for the last decade. The Gross Domestic Product (GDP) in Kenya was worth US \$ 74.94 Billion in 2017. The GDP value of Kenya represents 0.12 percent of the world economy. The economy of Kenya advanced 6.0 percent year-on-year in the third quarter of 2018. Since 2014, Kenya has been ranked as a lower middle-income country because its per capita GDP crossed a World Bank threshold. The economic expansion has been boosted by a stable macroeconomic environment, low oil prices, rebound in tourism, strong remittance inflows and a government led infrastructure development initiative.

Kenya imports machinery and transportation equipment, oil, petroleum products, motor vehicles, iron and steel, resins and plastic [US \$ 17.1 Billion in 2017] and exports US \$ 6.17 Billion tea, horticultural products, coffee, petroleum products, fish, cement, apparel⁴. The trade deficit of

Kenya Shillings (KES) is floating around 100 per US\$ and is stable. The inflation Rate in Kenya averaged 9.67 percent from 2005 until 2019. The annual inflation rate in Kenya fell to 4.70 percent in January 2019 from 5.71 percent in the prior month and below market expectations of 5 percent. The Central Bank of Kenya left its benchmark interest rate unchanged at 9.0 percent.

Kenya applies East African Community (EAC) Common External Tariff – In general, Customs duty is levied at rates between 0% and 100%, with an average rate of 25%. In regard to the sales tax, imports into Kenya are subject to a standard VAT rate of 16%, levied on the sum of the CIF value, duty, and other applicable taxes⁵.

Conclusion and associated Procurement Risk(s): Kenya as one of the fastest growing economies in Sub-Saharan Africa. The macro economic factors are stable. The domestic cement manufacturers are having adequate capacity to supply for construction works. The construction materials are available except Bitumen. The project specific requirements like construction equipment required by the contractors, high mast lamps, etc., needs to be imported. The procurement approach will consider these aspects while planning and provide adequate lead time and realistic timeframe for construction period.

Sustainability Aspects

Kenya's rapid population growth resulted in more than 40% of the population being under the age of 15, making Kenya's one of the countries in the world with highest population of young people.

The Bidding documents will have mandatory ESHS related clauses. The Bank has carried out the ESHS studies. The Bank is also conducting operation and Maintenance study to ensure the sustainability of the created assets at the informal settlements. The outcome of the study will be incorporated to this document and implemented from procurement perspective.

Conclusion and associated Procurement Risk(s): In KISIP 1, the counties were not existed during the project initiation. In KISIP 2, county government are expected to play role in need analysis, requirement capturing, contract management, owning of created assets through projects and their operation & maintenance, and ensure the sustainability. The institutional arrangements in the context of devolution are still evolving, including intergovernmental structures and mechanisms for intergovernmental cooperation and transfer of resources to deliver on policy priorities.

Technological Aspects

Kenya's ICT sector was liberalized in 2000, and this led to a technological revolution that has stimulated home-grown innovation and transforming Kenyan's lives. According to MasterCard, success of internationally recognized services like MPESA as a mobile money transfer platform are attributable to a lack of a traditional infrastructure and alternative conventional payment media.

Conclusion and associated Procurement Risk(s): The envisaged procurements and their pricing may not subject to technological changes except few like High mast lamp (energy efficiency). However, the project intends to use the ICT platform for Project Management Information System (PMIS) for monitoring (current Excel based system migrated to Web based system) and use of the geo tagging of the created assets through mobile applications (app). The same application also used for monitoring the progress.

Key Conclusions

- Needed selective procurement approach for implementation of integrated settlement plan in sensitive counties;
- (ii) Checks and balances should be incorporated in the implementation arrangements with regard to the roles and responsibilities of the counties in the procurement and contract management process;
- (iii) The procurements required imported inputs must have built in adequate time lines, realistic delivery and mitigate appropriate risks; and
- (iv) Existing excel based monitoring system needs to be strengthen the procurement monitoring process.

b. Client Capability and PIU Assessment

Kenya has a legal and regulatory framework that governs public procurement enacted in December 2015 which provides for open advertisement of procurement opportunities, universal eligibility, and an effective complaint handling mechanism hence conducive for the participation international/foreign service providers.

• **Prior Implementation Experience:** The PCU has experience in World Bank Financed Operations of implementation of KISIP 1, whereas the County staff are not familiar with World Bank Financed Operations. Two Supply Chain Management (SCM) officers functioning at the PCU are familiar with the Bank Financed operation in Procurement Guidelines Regime. Also, they are adequate experience in managing the procurement plan in the Bank's portal Systematic Tracking of Exchanges in Procurement (STEP). They need orientation and advanced training on Bank's New Procurement Framework (NPF) Procurement Regulations. The evaluation process is carried out by an Adhoc committee constituted for this purpose. These members are bound by the code of ethics for civil servants. To ensure the confidentiality till the notification to intent award, a robust framework and guidelines are required to strengthen the confidentiality during the evaluation process.

The KISIP 1 has operation manual was developed for management of project procurement and reference guide for implementation. For KISIP 2, this document may require re-alignment with changes in NPF and changed implementation arrangements (in discussion and to be incorporated after finalisation)

The roles and responsibilities of the counties in the procurement process: Counties to procure infrastructure contracts except the supervising consultants who will be procured by National KISIP PCT. The other remaining contracts shall be procured jointly by KISIP PCT and County Government as per project design

(in discussion and to be incorporated after finalisation)

As cited and recommended in the post procurement review reports for KISIP 1, the procurement file should comprise the payment and completion details. This aspect in record keeping may be strengthened.

- Need for hands-on support: The PCU is having adequate experience and having project procurement specialists cum SCM officers. Hence, hands on support is not required.
- **Contract management capability and capacity:** The PCU depends upon the supervision consultants for delivering the contract management function. Training on contract management may therefore be required especially for the management and supervision of large contracts.

This will be concluded once the Project Operations Manual has been finalized.

 Complaints management and dispute resolution systems: The Public Procurement and Asset Disposal Act 2015 [PPAD] also provides the option for submitting the complaints to the Public Procurement Review Board [PPRB]. The bidders can submit the complaints, which are not resolved at the

procurement entity level to the PPRB. This is an additional avenue besides judicial review.

· Learnings from Similar Projects:

Normally, two separate consultants were engaged for design and supervision. Requires coordination and the supervision consultants are taking time to design review, issuance of working drawings and inadequate/changed requirement may result in variations. Hence, it would be appropriate to combine the design and supervision roles, entrust to single consulting firm with design payment is based on the deliverables (Lump Sum) and supervision based on the time (Time based). This combination becomes Hybrid contract with the balance payment terms. The consultant should not take substantial amount of contract for design and not shown for supervision. This risk is mitigated through balance payment terms (not front loaded). Already a design consultant was hired in KISIP 1 to prepare the design and bid documents for 39 settlements in six counties (Nairobi, Kilifi, Kakamega, Kisumu, Nakuru, Mombasa).
