The development objective is to improve access to legal information and counseling services for 15,000 poor and vulnerable persons (of which 60% are women) in selected rural districts to enhance protection and fulfilment of their natural resources and livelihood rights.

The US\$2.51 million grant for the project was declared effective on November 8, 2021. The WB approved the Sub-Grant Manual in December, 2021 and the disbursement conditions for Component 2 were lifted in February 2022 by written notification to Helvetas. The Project Management Unit (PMU) has been partly established with the recruitment of a Project Manager.
