Implementation Status and Key Decisions

Regarding Component 1, all but three of the Disbursement Linked Indicators (DLIs) that were anticipated to be completed by June 2015 were achieved as scheduled, and a subsequent DLI was achieved in October 2015 with the approval of the Investment Reform Map by the government. These achievements helped establishment of foundation for the institutional reforms required for improved quality of delivery of the Trade Promotion and Quality Infrastructure services.

The newly established Development Foundation of Armenia (DFA), which is an implementing agency for Component 2, has successfully recruited its key staff members and is now ready for the implementation of the Project activities. Recruiting for the international Resident Advisor is underway. Regarding Component 3, the new organizational chart for the National Institute of Metrology (NIM) was approved by its board. The job descriptions for the Industrial Metrology staff of the NIM has also been approved. Hiring process for the staff will commence once the Resident Advisor is hired. The organizational chart and job descriptions for the National Accreditation Board (NAB) staff have also been developed and approved. The recruiting for the international Resident Advisors for NIM and NAB is underway.

Recruiting for the staff of the PMU, which is responsible for coordination of the overall Project implementation and is the implementing agency for Component 4, is also underway. It is expected that the PMU will be fully staffed by the end of November 2015.

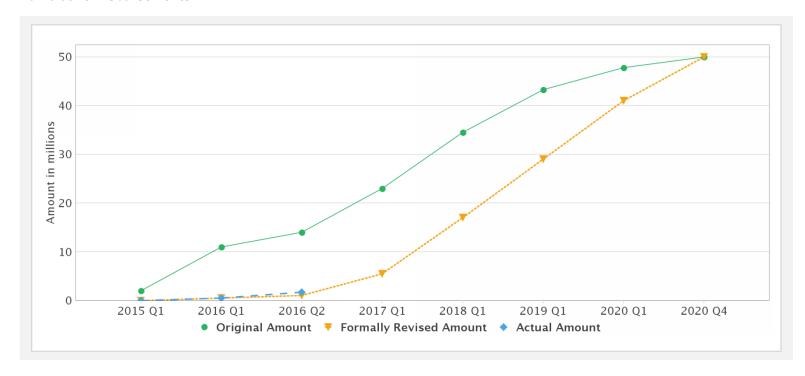
