Excellency:

We refer to the Additional Financing Agreement (“Agreement”), dated June 19, 2019 between Burkina Faso (“Recipient”) and the International Development Association (“Association”) for the abovementioned Project. Please note that the capitalized terms used in this letter (“Amendment Letter”) and not defined herein have the meanings ascribed to them in the Agreement.

We are pleased to inform you that the Association proposes, through this Amendment Letter, to amend the Additional Financing Agreement as follows:

1. Schedule 1 to the Agreement is amended as reflected in Schedule 1 to the Third Additional Financing ASP Grant Number TF0B6352.
2. The withdrawal table in Section III.A of Schedule 2 to the Agreement is hereby amended to read as follows:
