Implementation Status and Key Decisions

The loan for the Second Municipal Services Improvement Project (MSIP2) in the amount of EUR25 million was approved by the Board on January 11, 2016, and the loan agreement was signed on January 14, 2016. The project aims to improve transparency, financial sustainability, and inclusive delivery of municipal services across the country.

MSIP2 will provide sub-loans to municipalities for infrastructure investments such as water supply, sewerage, solid waste management, local roads, energy efficiency improvements to municipal buildings, and other high priority municipal infrastructure investments with clear impact on welfare of citizens and efficiency of services. The project also introduces a grant component to enhance service delivery and infrastructure for poorer and marginalized communities within municipalities throughout FYR Macedonia.

Before the Board approval, it was discussed and agreed with the Government that MSIP2 will not be declared effective and no funds will be disbursed until after the elections to ensure that political parties do not use the project in the context of their election campaigns. With changing electoral time in the country, the Bank management has revised its decision to allow municipalities to take advantage of the 2016 construction season to implement basic infrastructure investments, and declare effectiveness of MSIP2 loan agreement on July 14, 2016. The decision to declare effectiveness was taken with municipalities and their citizens in mind, since MSIP2 will finance local level projects aimed at improving basic infrastructure, with an objective to enhance transparency, financial sustainability, and inclusive delivery of targeted municipal services.

All municipalities are eligible and encouraged to participate in the MSIP2. In order to ensure transparency of the sub-loan application process, MSIP2 introduces a Call for Proposals for municipal sub-loans which is similar to the one successfully applied under the MSIP IPA rural investment window. The Ministry of Finance published the first Call for Proposals on September 7, 2016, with the application deadline of November 7, 2016.




