# Introduction

In accordance with the Bank's revised disclosure policy, since FY02, the SOPE Report is available to the public.

The report is intended to bridge the gap in information available to the public between the Project Appraisal Document or Program Document, disclosed after the Bank approves a project, and the Implementation Completion Report, disclosed after the project closes.

In addition to the project progress description, the FY10 SOPE report<sup>1</sup> contains project level comparisons of disbursement estimates and actual disbursements, and a table showing the loan/credit/grant amount and disbursements to date.


## The project was restructured, or received Additional Financing during FY 10

Several training workshops were conducted to build the capacity of the ministry staff to manage projects.


## The project was restructured, or received Additional Financing during FY 10

About 45 km of water mains and distribution pipelines were completed. The production capacity improved after commissioning of new pumps and electrical equipment in pumping stations and treatment plants. The sewerage network in Sadr City is almost complete. The training program is also progressing well.


## The project was restructured, or received Additional Financing during FY 10

A restructuring was approved by the RVP on March 31, 2010, to reallocate about \$6 million remaining from the Additional Financing of \$10 million. The amount was reallocated to finance additional capacity building for the Economic Development Fund, support needed reform in the communications sector and promote private sector participation in the communications sector.

**Progress toward achieving development objective(s):** Capacity of the Economic Development Fund (EDF) has been strengthened and it should be able to resume its activities of providing technical and financial support to Iraqi Small and Medium Enterprises (SMEs). The two telecom components, establishment of the Iraqi Inter-banking Network and the rehabilitation of the microwave network have been completed and are fully operational. However, with the recent attack on the Central Bank of Iraq (where the Iraq Inter-Banking Network (IIBN) equipment was located), some equipment was destroyed. The team is in the process of assessing the damage.


### The project was restructured, or received Additional Financing during FY 10

In order to build on the success of this project, \$3 million in additional financing was agreed on June 30, 2010 and the closing date extended to September 2012. The additional financing will allow the project to provide: (i) capacity building and technical assistance for implementation of the Poverty Reduction Strategy; (ii) capacity building and technical assistance for monitoring progress of the Poverty Reduction Strategy; and (iii) financial, capacity building and technical assistance for poverty measurement (including a second round of the household survey).

**Progress toward achieving development objective(s):** The Council of Ministers adopted the national poverty line in May 2009 and the Poverty Reduction Strategy in November 2009 (Decree 409). The Poverty Reduction Strategy has been integrated into the National Development Plan, the 2010 budget, and the United Nations Development Assistance Framework. Under the Bank-Executed companion trust fund, we conducted 9 workshops for our Iraqi counterparts (providing 526 person days of training) to assist them in developing the Poverty Reduction Strategy.







**Project Development Objectives:** The objective is to develop more effective, accountable and transparent public financial management. Support will be provided for strengthening budget management, improving public financial reporting and control, strengthening public procurement, and establishing the tools, systems and institutions required to build capacity for effective public financial management.

**Progress toward achieving development objective(s):** Since the launch of the project an evolving Medium-Term Fiscal Framework (MTFF) is in place. A multi-year budget strategy was introduced in 2010-2012. The 2011 Budget Call Circular was the first to include hard ceilings for spending units. Following the introduction of a new GFS compliant Chart of Accounts in 2007 an Accounting Manual was developed in 2010 to facilitate implementation. As a result government financial reports and audits are being prepared earlier and are more informative and accurate. Incremental improvements in public finance management are leading to better budget execution: from 25-30% in 2006-7 to over 50% in 2008. In 2009 the investment budget is on track for an execution rate of over 70%. Well planned and executed public investment is laying the foundation for improved service delivery and economic reconstruction. The Project also contributed to improved coordination involving key donor at all stages.

Hence the closing date of the project was extended to June 30, 2013 in order to ensure that the project development objectives are achieved through full implementation of its key components. No changes were made to the project development objectives.

**Progress toward achieving development objective(s):** Some progress has been made in signing consultancy contracts, issuing Request for Proposals, and receiving proposals despite the difficulty in finding international experts that are willing to work on the ground in Iraq with the security situation. Further progress is expected moving forward with project implementation.
