## Bangladesh: Emergency 2007 Cyclone Recovery and Restoration Project (IDA Credits No. 4819-BD and No. 5342-BD) - Amendment to the Legal Agreements

We refer to the following agreements ("Agreements") for the above-mentioned Project between the People's Republic of Bangladesh ("Recipient") and the International Development Association ("Association): (i) the Financing Agreement for the Additional Credit No. 4819 dated November 11, 2010, as amended; and (ii) the Financing Agreement for the Additional Credit No. 5342 dated June 9, 2014. We also refer to the letter dated December 14, 2015 from the Economic Relations Division, Ministry of Finance, requesting us to reallocate the proceeds of both credits. Following agreements reached between the Recipient and the Association, we propose to amend the Agreements as follows:

## I. Financing Agreement for the Additional Credit No. 4819

1. The following terms of the table in paragraph 2 of Section IV.A of Schedule 2 shall be amended as follows:
