Implementation Status and Key Decisions

The first wave of cash transfers to around 15,000 households in the Nord began on September 15, 2015 and five payments have been made already. The second wave to around 14,000 more households in the East is planned for March 2017, and of 13,000 more in the East-Central region in April 2017. The system building component has taken on new dynamism with a committee of stakeholders planning for next steps. A number of shortcomings related to fiduciary and project management detected during past missions are being addressed by an organizational review and restructuring.

In fact, 15,071 women beneficiaries (subhouseholds) are enrolled in the program. This means 79560 individuals (including children) are currently reached.


