


***Amendment No. 1 to the Administration Arrangement between the United Kingdom of Great Britain and Northern Ireland, acting through the Foreign, Commonwealth and Development Office and the International Bank for Reconstruction and Development and the International Development Association regarding the Human Rights, Inclusion and Empowerment Multi-Donor Trust Fund (Trust Fund No. 073224)***

1. Reference is made to the Administration Arrangement between the United Kingdom of Great Britain and Northern Ireland, acting through the Foreign, Commonwealth and Development Office (the “Donor”) and the International Bank for Reconstruction and Development and the International Development Association (collectively, the “Bank” and together with the Donor, the “Participants” and each a “Participant”) regarding the Human Rights, Inclusion and Empowerment Multi-Donor Trust Fund (Trust Fund No. 073224) (the “Trust Fund”) effective as of August 18, 2021 (the “Administration Arrangement”).
2. The Bank acknowledges that the Donor has decided to provide the sum of thirty-two thousand four hundred thirty nine and 90/100 Pound Sterling (GBP 32,439.90) (the “Contribution”) for the Trust Fund in accordance with the terms of the Administration Arrangement.
3. The Donor will deposit the Contribution in the currency specified in paragraph 2 above into such bank account designated by the Bank promptly following countersignature of this amendment (the “Amendment”) and submission of a payment request by the Bank.
4. When making a deposit, the Donor will instruct its bank to include in its deposit details information (remittance advice) field of its SWIFT deposit message, information indicating: the amount deposited, that the deposit is made by the Donor for Trust Fund No. 073224 (the Human Rights, Inclusion and Empowerment Multi-Donor Trust Fund), and the date of the deposit (the “Deposit Instructions”). In addition, the Donor will provide a copy of the Deposit Instructions to the Bank’s Accounting Trust Funds Division by e-mail sent to [tfremitadvice@worldbank.org](mailto:tfremitadvice@worldbank.org) or by fax sent to (202) 614-1315.
5. All other terms of the Administration Arrangement will remain the same.
