

Re: Iraq: Public Finance Management Reforms Project (Grant. No.TF094552) Amendment to Grant Agreement

Excellency:

We refer to the Grant Agreement, dated July 20, 2009, between the Ministry of Finance of Iraq (Recipient) and the International Development Association (World Bank), for the above-mentioned Project (the Project). We also refer to a letter from the Deputy Finance Minister dated October 7, 2012 requesting certain amendments to the Grant Agreement.

We are pleased to inform you that, after due consideration, the World Bank concurs with the request, and consequent y the Grant Agreement is hereby amended as set forth below.

A new paragraph as "Part E" is introduced in Schedule 1 to the Grant Agreement, which reads 1. as follows:

"Part E: Integrated Finar cial Management Information System (IFMIS)

Implementation of IFMIS by the Ministry Finance to: (i) provide the capacity to automate the bidget preparation process and ensure complete and accurate budget formulation and presentation; (ii) increase its ability to undertake central control and monitoring of expenditure and receipts in government ministries, departments and spending units; anc (iii) provide access to comprehensive and meaningful information on budgetary, finar cial and operation performance during the financial year."

2. The Table under paragraph A 2 of Section IV of Schedule 2 to the Grant Agreement is amended to read as follows:

- Paragraph B.2 under Section V of Schedule 2 to the Grant Agreement is amended to read as 3. follows:
 - "2. The Closing Date referred to in Section 3.06 of the Standard Condition is August 31, 2013."

Except as specifically amended by this amendment letter, all other provisions of the Grant Agreement remain in full force and effect.
