Implementation Status and Key Decisions

Following approval of the project on November 6, 2020, the Financing Agreement was co-signed by on December 17, 2020. Steps are now being taken to satisfy the conditions agreed during project negotiations for the project to become legally effective. All three conditions have been satisfied and the process of reviewing the legal documents and issuing a legal opinion is underway. Efforts to satisfy conditions required to be met for the disbursement of funds, namely the preparation and adoption of Project Operations Manuals, are also underway. All effectiveness and disbursement conditions are expected to be satisfied by end March 2021. With the establishment of a Project Implementation Unit in the Ministry of Reintegration and Temporarily Occupied Territories, the project is expected to begin implementation activities by end April 2021.


