### Implementation Status and Key Decisions

The Project became effective in March 2015. Implementation *Progress* to date remains as Moderately Satisfactory while the World Bank task team recognizes the substantial progress made in several key areas such as progress with construction works, strengthening of irrigation and drainage institutions and the piloting of systematic land registration procedures. Much remains to be done during the remaining three years of extended project duration. Upon request of the government of Georgia, the World Bank recently (June 14, 2018) approved a two-year project closing date extension. Activities planned under Component 1 (Irrigation and Drainage Improvement) will require particular diligence towards design and smooth implementation of Batch 2 civil works in all three irrigation schemes targeting secondary and tertiary networks. In parallel, it will be crucial for the project to establish water user organizations and more importantly provide institutional support enabling them to take over management responsibility at local levels. Activities implemented under Component 2 (Land Market Development) are progressing well. They are expected to be completed as previously planned.
