Amendment to the Administration Arrangement between the Netherlands Minister for Development Cooperation and the International Development Association concerning the Multi-Donor Trust Fund for the Emergency Demobilization and Transitional Reintegration Project in Burundi (TF071297)

- 1. We refer to the Administration Arrangement between the Government of the Netherlands, represented by its Minister for Development Cooperation (the "Donor") and the International Development Association ("IDA"), regarding the Multi-Donor Trust Fund for the Emergency Demobilization and Transitional Reintegration Project in Burundi (TF071297) (the "Trust Fund") effective on November 23, 2009 (the "Administration Arrangement").
- 2. Pursuant to recent discussions between the Bank and the Donor, the Bank proposes to amend paragraph 8 of Annex 2 to the Administration Arrangement to extend the closing date to June 30, 2013 to read as follows:

Paragraph 8:

- "8.1. It is expected that the Contribution funds will be fully disbursed by IDA in accordance with the provisions of this Agreement by June 30, 2013. IDA will only disburse Contribution funds for the purposes of this Agreement after such date with the written approval of the Donors."
- 3. All other terms of the Administration Arrangement shall remain the same.

- 4. The Bank will disclose this Agreement and related information on this Trust Fund in accordance with the World Bank Policy on Access to Information. By entering into this Agreement, the Donor consents to disclosure of this Agreement and related information on this Trust Fund.
- 5. We propose that this letter shall constitute an amendment to the Administration Arrangement between the Bank and the Donor. Please confirm your acceptance to the foregoing, on behalf of the Donor, by signing and dating the two originals, retaining one original for your records and returning the other original to the Bank. Upon receipt by the Bank of the original Amendment countersigned by you, this Amendment will become effective as of the date of the countersignature.
