Amendment to the Financing Agreement
Amendment to the GEF Grant Agreement

Honorable Minister,

We refer to: (i) the Financing Agreement between United Republic of Tanzania (the “Recipient”) and the International Development Association (“Association”) and (ii) the Grant Agreement between the Recipient and the International Bank for Reconstruction and Development (“World Bank”) (together the “Agreements”), dated March 12, 2015 for the above referenced Project. For the purpose of this letter, the Association and the World Bank will be referred to as the “Association”. Please note that the capitalized terms used in this letter (“Amendment Letter”) and not defined herein have the meanings ascribed to them in the Agreements.

Pursuant to the discussions held during the 7th implementation mission dated November-December 2019, and to your letter dated December 10, 2020, we are pleased to inform you that the Association concurs with your request to restructure the Project and propose to amend the Agreements as below:

1. ***The Project Description under Schedule 1 of the Agreements is amended as follows:***

Paragraph (b) of Component C: 2 (Expanding opportunities for priority fisheries and value addition) is deleted.

2. ***Section I.3(a) (ii) of Schedule 2 of the Agreements is amended to read as follows:***

“(ii) the Zanzibar PIU within Zanzibar's Ministry of Blue Economy and Fisheries with the responsibility for day-to-day management and implementation of the Project activities within Zanzibar, and efficient implementation, communication and coordination of said Project activities, with the participating MDAs, the private sector and key institutions; and”.

3. *The tables in Section IV.A.2 of Schedule 2 of the Agreements are amended as set out in Annex 1 to this Amendment Letter.*
4. *Section IV.B.2 of Schedule 2 (Withdrawal Period) is amended as follows:*

“2. The Closing Date is September 30, 2022.”

Please confirm your agreement with the foregoing amendment, on behalf of the Recipient, by signing, dating and returning to the Association the enclosed copy of this Amendment Letter. This Amendment Letter shall become effective as of the date of its countersignature upon receipt by the Association of a countersigned copy.
