## **EXECUTIVE SUMMARY**

- 1. Since the inception of the HIPC Initiative in 1996, total debt relief provided by IDA under the HIPC Initiative and the MDRI is currently estimated at SDR 35.5 billion (equivalent to USD 54.0 billion).** Two thirds of this amount (SDR 24.7 billion, or USD 37.6 billion) relates to the MDRI, the balance to the HIPC Initiative. Total MDRI costs in SDR terms have not changed significantly since MDRI inception in April 2006. However, costs in the outer decades (fiscal years 2020-2044) have increased while costs over the IDA14-15 disbursement period (fiscal years 2007-2019) fell by about SDR 0.8 billion. These shifts are primarily due to the postponement of projected decision and completion point dates for a number of pre-decision and decision point HIPCs.
- 2. As of September 30, 2007, 22 HIPC countries have reached the HIPC completion point, receiving a total of SDR 27.2 billion (USD 41.5 billion) of irrevocable debt relief, equivalent to about 77 percent of the total debt relief to be provided by IDA.** Of this amount, an estimated SDR 19.3 billion has been provided under the MDRI and the balance of SDR 7.9 billion under the HIPC Initiative. The remaining 18 HIPC countries will benefit from the MDRI upon reaching the completion point.
- 3. For IDA15, donors are requested to contribute SDR 1,221 million to cover IDA's HIPC-related costs.** This amount represents the updated HIPC costs over the IDA15 commitment period (FY09-11).
- 4. As of September 30, 2007, donors have provided unqualified, firm financing commitments to the MDRI of SDR 2.9 billion (USD 4.3 billion), representing 12 percent of total MDRI costs.** When adding qualified commitments of SDR 14.6 billion (USD 22.3 billion), total donor financing commitments received represent 71 percent of total MDRI costs.
- 5. Due to the MDRI, IDA forgoes an estimated SDR 7.0 billion (USD 10.6 billion) of credit reflows that are no longer available to support IDA14 and IDA15 disbursements.** Over the disbursement horizon of IDA14 (fiscal years 2007-2016), MDRI costs are estimated at SDR 4.7 billion (USD 7.2 billion). The IDA15 disbursement period (fiscal years 2009-2019) adds another SDR 2.2 billion (USD 3.4 billion) to the MDRI costs.
- 6. For IDA15, additional firm financing commitments for the MDRI of SDR 4,148 million (USD 6,325 million) are being sought from donors.** This includes SDR 1,965 million (USD 2,998 million) to support IDA14 disbursements and concerns only those donors that have not yet provided such commitments during IDA14. The balance of SDR 2,182 million (USD 3,327 million) is sought from all donors – except those that have already financed their share of the 40-year total MDRI costs – to cover the incremental MDRI costs over the IDA15 disbursement period.
- 7. Revised cost estimates for the MDRI will be reflected in the compensation amounts shown in the tables attached to the IDA15 Resolution of IDA's Board of Governors.** Such adjustments at the time of each replenishment were contemplated in the MDRI Resolution approved by IDA's Board of Governors. In addition, each donor has agreed in its Instrument of Commitment ("IoC") to amend the IoC so as to reflect these changes.

**I. INTRODUCTION**

1. This report provides the second update on IDA's costs of implementing the Multilateral Debt Relief Initiative (MDRI) and on the associated donor financing commitments, as of September 30, 2007. It follows up on the first such report as of December 31, 2006.<sup>1</sup>
2. The report provides an input into the ongoing IDA15 discussions. Donors would apply the updated HIPC and MDRI cost data as of September 30, 2007 for their additional financing contributions over the IDA15 disbursement period. The report also responds to the request by donors for ongoing monitoring of donor contributions to the MDRI and to review the status of MDRI financing in conjunction with regular IDA replenishments.
3. The report is structured as follows. Section II provides background information on IDA's implementation of the MDRI. Section III offers updated estimates on the volume of debt relief provided by IDA to beneficiary countries under the MDRI. Section IV discusses donor financing for HIPC-related costs in the context of IDA15. Section V shows updated information on financing commitments received for the MDRI replenishment of IDA and the additional donor financing sought in the context of IDA15. Section VI concludes with the adjustments to the compensation amounts from donors, resulting from the updated MDRI cost estimates.
4. The data in this report are shown in nominal value terms as this forms the basis for donors' compensatory contributions to IDA over time. Data are presented in SDR and in USD equivalent terms, as well as in national currency where applicable, applying the appropriate foreign exchange rates.<sup>2 3</sup>

**II. BACKGROUND**

5. The MDRI was proposed by G8 Heads of States in July 2005 and subsequently endorsed by the Development Committee in September 2005. The MDRI provides 100 percent cancellation of IDA, AfDF, IDB<sup>4</sup> and IMF eligible debt for countries that reach the HIPC

completion point. Its objectives are twofold: deepening debt relief to HIPC countries, while safeguarding the long-term financial capacity of IDA and the AfDF; and encouraging the best use of additional donor resources for development by allocating them to low-income countries on the basis of policy performance. Debt relief provided under the MDRI is in addition to existing debt relief commitments by IDA and other creditors under the Enhanced HIPC Debt Initiative. Under the financing package for the MDRI, donors agreed to finance IDA's MDRI costs on a 'dollar-for-dollar' basis.

6. The Board of Executive Directors of IDA approved IDA's participation in the MDRI on March 28, 2006.<sup>5</sup> IDA's Board of Governors adopted the Resolution authorizing an increase in IDA resources to cover MDRI-related costs on April 21, 2006.<sup>6</sup> The Board of Executive Directors of IDA approved IDA's implementation of the MDRI as of July 1, 2006, i.e. the beginning of fiscal year 2007.<sup>7</sup> The MDRI replenishment of IDA became effective on August 4, 2006.

### III. DEBT RELIEF PROVIDED BY IDA

#### A. Total Debt Relief

7. **Debt relief since HIPC inception.** Since the inception of the HIPC Initiative in 1996 and the inception of the MDRI in 2006, total debt relief to be provided by IDA under HIPC and MDRI combined is currently estimated at SDR 35.5 billion (see enclosed Table 1a).<sup>8</sup><sup>9</sup> This is a reduction of SDR 0.7 billion with respect to IDA's debt relief estimates as of end-2006. The difference is explained primarily by the exclusion of debt relief estimates for the Kyrgyz Republic<sup>10</sup>, the postponement of projected decision and completion point dates for a number of pre-decision and decision point HIPC countries, and the effects of applying the IDA15 foreign exchange reference rates. The reduction in cost estimates is however partially offset by the inclusion of debt relief costs for Afghanistan.<sup>11</sup> In USD equivalent terms, IDA's updated total debt relief estimate equals USD 54.0 billion.

8. The total amount of SDR 35.5 billion (USD 54.0 billion) can be broken down into three elements (Tables 1a and 1b):

- HIPC debt relief provided by IDA prior to July 1, 2006, of SDR 2.6 billion (USD 4.0 billion). This amount has been financed primarily through IBRD net income transfers to the HIPC Trust Fund, complemented by some bilateral donor financing;
- HIPC debt relief by IDA starting from July 1, 2006 (i.e., from FY07 onward), estimated at SDR 8.2 billion (USD 12.4 billion). Donors have committed to finance these amounts over time as reflow losses occur;<sup>12</sup> and
- MDRI debt relief by IDA starting from July 1, 2006 over the implementation period of the MDRI (FY07-44), estimated at SDR 24.7 billion (USD 37.6 billion). Donors have also agreed to finance these amounts over time as reflow losses occur.<sup>13</sup>

9. **Irrevocable debt relief to completion point HIPC**s. As of September 30, 2007, 22 countries have reached the HIPC completion point. These countries have received a total of SDR 27.2 billion (USD 41.5 billion) of irrevocable debt relief from IDA, equivalent to 77 percent of the total debt relief to be provided by IDA. Of this amount, an estimated SDR 19.3 billion has been provided under the MDRI and the balance of SDR 7.9 billion under the HIPC Initiative (Table 1a).

10. **Donor financing of IDA's debt relief costs from FY06 onward.** Donor financing for IDA's debt relief under the *HIPC Initiative* was introduced in the IDA14 replenishment, beginning in *FY06*. Donor financing of *MDRI*-related costs of IDA began in *FY07*, at the start of IDA's implementation of the MDRI, and is scheduled to end by *FY44* when the last IDA credit eligible for cancellation under the MDRI would have matured. Over this donor financing period *FY06-44*, IDA is estimated to provide total debt relief of SDR 33.2 billion (USD 50.5 billion) (Tables 2a and 2b). About 90 percent of this total amount represents cancelled credit principal, with the balance representing IDA's forgone service charge income on the cancelled credits.

11. **Time profile of forgone credit reflows.** Due to the HIPC Initiative, IDA has lost reflows equal to SDR 339 million (USD 513 million) in *FY06*, the first year of the IDA14 period (Tables 3a and 3b). In *FY07*, the first year of MDRI implementation, the volume of lost reflows due to HIPC and MDRI combined increased to SDR 623 million (USD 934 million). For *FY08*, the projected loss of reflows equals SDR 677 million (USD 1,013 million). Annual volumes of forgone reflows are projected to peak by *FY23*, at SDR 1,328 million (USD 2,025 million), thereafter decreasing gradually until the final year, *FY44* (Chart 1).

12. **Credit reflows lost for IDA14 and IDA15.** Disbursements on credits and grants resulting from new financing commitments made during IDA14 and IDA15 extend out over the period *FY06-19*. Over this combined disbursement period, IDA is projected to lose an estimated SDR 13.8 billion (USD 21.0 billion) in credit reflows due to debt relief (Tables 4a and 4b). This



amount is split nearly equally between reflows lost due to the HIPC Initiative of SDR 6.8 billion (USD 10.4 billion, Tables 5a and 5b) and due to the MDRI of SDR 7.0 billion (USD 10.6 billion, Tables 6a and 6b).

## B. Debt Relief under the MDRI

13. **Evolution of MDRI cost estimates.** Table A illustrates the evolution of IDA's estimated loss of credit reflows due to the MDRI. Total estimated costs since establishment of the MDRI in April 2006 have decreased slightly, by SDR 137 million. In US dollar terms, however, MDRI costs have increased by USD 935 million as a result of the IDA15 foreign exchange reference rates, which reflect the depreciation of the US dollar vs. the SDR basket over the past 18 months.<sup>14</sup> The decrease of estimated MDRI costs in SDR terms since MDRI establishment in April 2006 for which donors have already provided financing commitments will be applied and credited according to each donor's burden share.

14. Estimated MDRI costs fell more significantly over the first decade of MDRI implementation (FY07-16), by some SDR 522 million, followed by another reduction of SDR 314 million over the next three years (FY17-19). The total reduction of estimated MDRI costs over the combined IDA14 and IDA15 disbursement period is SDR 835 million, thereby lowering the volume of donors' financing commitments needed in the context of the IDA15

replenishment. As previously mentioned, these reductions are driven primarily by the exclusion of debt relief estimates for the Kyrgyz Republic, the postponement of projected decision and completion point dates for a number of pre-decision and decision point HIPCs, and the effects of applying the IDA15 foreign exchange reference rates. In contrast, MDRI cost estimates have increased in the outer years (FY20-44), by SDR 698 million.

#### IV. DONOR FINANCING FOR HIPC-RELATED COSTS

15. IDA14 was the first replenishment where donors agreed to finance IDA's forgone credit reflows due to the HIPC Initiative.<sup>15</sup> Donor financing of HIPC costs occurs on a pay-as-you-go basis, over the 3-year commitment period of each IDA replenishment. HIPC debt relief is defined and extended to recipient countries in US dollar terms.

16. **Donor financing in IDA14.** Based on debt relief estimates as of September 30, 2007, over the 3-year commitment period of IDA14 (FY06-08), IDA forgoes a volume of USD 1,708

million of credit reflows due to the HIPC Initiative (see Table B). After using remaining resources of USD 384 million from prior IBRD transfers to the HIPC Trust Fund, a balance of about USD 1,324 million of HIPC costs during FY06-08 is being financed by donor commitments received under IDA14. This compares to the original HIPC cost estimate of USD 1,693 million for the IDA14 period, for which donors provided financing commitments under the IDA14 replenishment. The reduction in the HIPC cost estimate is primarily due to the postponement of projected decision dates for a number of pre-decision point HIPCs during the IDA14 period. As a result, donors' required HIPC contributions for the IDA15 period will be reduced by a carry-over amount of USD 369 million.

17. **Donor financing in IDA15.** For the IDA15 commitment period (FY09-11), the updated HIPC costs of IDA are estimated at USD 2,234 million. After deducting the carry-over amount from IDA14, the net financing requirement for donors to cover IDA's HIPC costs in IDA15 are USD 1,865 million. In SDR terms, at the IDA15 foreign exchange reference rates, the amount of HIPC-related costs to be financed by donors in IDA15 is SDR 1,221 million.

## V. DONOR FINANCING COMMITMENTS TO THE MDRI

18. **The MDRI replenishment of IDA.** To finance IDA's forgone credit reflows under the MDRI, donors established a separate MDRI replenishment, spanning four decades (FY07-44). In order to preserve IDA's advance commitment capacity - under which IDA uses its stream of available future credit reflows to back disbursements on approved credits and grants - donors acknowledged the need to provide unqualified, firm MDRI financing commitments over a rolling decade, thereby matching the disbursement period of each future IDA replenishment.<sup>16</sup> The long-term nature of MDRI financing commitments may present a challenge for some donors who

may not be able to make firm commitments over such a long time period due to legislative or budgetary constraints.

**19. Overall MDRI financing status.** As of September 30, 2007, donors have provided unqualified, firm financing commitments to the MDRI of SDR 2.9 billion (USD 4.3 billion) (see Table C, also enclosed Tables 7a and 7b), representing 12 percent of total MDRI costs. In addition, donors provided qualified financing commitments of SDR 14.6 billion (USD 22.3 billion).<sup>17</sup> Taken together, unqualified and qualified financing commitments received represent 71 percent of total MDRI costs.

**20. MDRI financing received for IDA14 and IDA15.** Over the disbursement horizon of IDA14 (FY07-16), MDRI costs are estimated at SDR 4.7 billion (USD 7.2 billion). Against this amount, donors have provided nearly 84 percent of financing commitments, including 57 percent of firm, unqualified commitments and a further 27 percent of qualified commitments. The IDA15 disbursement period (FY09-19) adds another SDR 2.2 billion (USD 3.4 billion) of MDRI

costs, of which 1 percent are covered by firm, unqualified donor financing commitments and 78 percent are covered by qualified donor financing commitments. Please refer to enclosed Tables 8-11 for further details on the extent of donors' current financing commitments to the MDRI.

21. **Incremental MDRI financing commitments sought in the context of IDA15.** Over the IDA14 disbursement period (FY07-16), additional firm, unqualified financing commitments for the MDRI of SDR 1,965 million (USD 2,998 million) are being sought from donors in the context of IDA15 (see Table D). These commitments concern only those donors that have not yet provided such commitments during the IDA14 period.

22. Moreover, for the IDA15 disbursement period, donors are asked to provide additional firm, unqualified financing commitments for the MDRI of SDR 2,182 million (USD 3,327 million). These additional commitments concern all donors, with the exception of those donors that have already provided a firm, unqualified commitment over the entire 40-year period of the MDRI replenishment.

23. In total, therefore, firm financing commitments for the MDRI of SDR 4,148 million (USD 6,325 million) are being sought from donors. Enclosed Tables 12 a-c provide details, per donor country, on the extent of the additional firm, unqualified MDRI financing commitments sought within the context of the IDA15 replenishment.

## VI. ADJUSTMENTS TO MDRI COMPENSATION AMOUNTS

24. The MDRI report and Resolution<sup>18</sup> established a mechanism for IDA to make annual adjustments to the overall MDRI compensation schedule in order to reflect updated cost estimates. The updated, annual MDRI compensation schedule for donors is shown in the attached MDRI Table 1. In addition, the MDRI Resolution also provided that every three years, normally at the time of a regular replenishment, adjustments would be made by IDA to the compensation amounts payable by each donor. Updated annual costs are broken down by donor and fiscal year in the attached MDRI Tables 2a and 2b. In their Instruments of Commitment for the MDRI replenishment, donors agree to amend the IoC to reflect any such adjustments in their individual payment schedules. IDA will notify members of the corresponding adjustment necessary in their Instruments of Commitment through tables to be included in the IDA15 Resolution.
