Amendment to the Financing Agreement*

Dear Mr. Díaz:

We refer to the Financing Agreement (the “Financing Agreement”) between the Plurinational State of Bolivia (the “Recipient”) and the International Development Association (the “Association”), dated May 17, 2011, for the above referred Project. Please note that capitalized terms used in this letter (“Amendment Letter”) and not defined herein have the meaning ascribed to them in the Financing Agreement.

In response to letter MPD/VIPFE/DGGFE/UOF-NE 2266/2019 dated September 6, 2019 and letter CEX-PMAR/0110/2019 dated September 27, 2019, we are pleased to inform you that the Association concurs with your request. Accordingly:

1. Part 2 in Schedule 1 to the Financing Agreement is hereby amended to read in its entirety as follows:
 - “(a) Supporting Phase II of the *Rurrenabaque* Airport Improvement Program, through: (i) the carrying out of the necessary civil works and supervision activities for the construction of taxiways, apron, control tower, operations building, rescue and fire-fighting buildings, an access road, a passenger terminal, a paved fire truck access, secure airport perimeter fencing works, platform construction and a drainage system; and (ii) the acquisition and installation of aviation control, rescue, firefighting, medical, safety, meteorological and security equipment.

- (b) Provision of support for the carrying out of the necessary audits under the Project.
- (c) Provision of administrative and operational support to AASANA in the administration, monitoring, evaluation, coordination and supervision of the implementation of Part 2 of the Project.”
3. Part 3 (a) in Schedule 1 to the Financing Agreement is hereby amended to read in its entirety as follows:
- “(a) Strengthening the capacity of: (i) ABC to perform its functions effectively and efficiently, through the provision of technical assistance, training, and incremental operational costs required for Project administration and monitoring, and to implement the Good Governance and Anti-Corruption Action Plan; and (ii) AASANA to implement the Good Governance and Anti-Corruption Action Plan.”
4. Section III.D.2 of Schedule 2 to the Financing Agreement is hereby deleted in its entirety.
5. The table in Section IV.A.2 of Schedule 2 to the Financing Agreement is hereby replaced in its entirety with the table set forth below:


