#### Implementation Status and Key Decisions

In general, a good progress is observed in the technical and financial aspects of the project: Sector reforms are gradually being implemented (training of school directors under the new curriculum, adoption of new education policy act). The new UFP coordinator was recruited and is



operational since May 1, 2022. The covid-19 response component is progressing well, but a request has been submitted to the Global Partnership for Education (GPE) for a six-month extension of the closing date from June 30, 2022 to December 31, 2022.

Out of the two Project Development Objectives (PDO) indicators, one is already above final target and the other one is on target to reach the final target by the project closing date. On Implementation Progress (IP), two components have been upgraded to Satisfactory based on their recent performance despite the two years COVID situation and absence of in person WB mission: the component 1 "Teachers training" is currently out passing the planned targets, and the component 7 "Support to COVID situation" has reached full implementation with less than 2 percent uncommitted and all planned activities under completion/delivery. Out of 34 intermediate indicators, 6 have reached their final target, 20 are progressing in the right direction but 8 don't have any progress reported yet.

For the three Performance-Based Conditions PBCs indicators, the target for one has been met, and two are progressing, from which one is awaiting the evaluation and the final report, which will be available in September 2022. For the GPE Variable Part (VP) indicators, from 13 indicators, two have been achieved; one is due in 2023; three indicator targets were rescheduled to 2022 and are still expected to reach their targets in 2022; one indicator was partially met; and one indicator is awaiting the technical report; one indicator was delayed and therefore, the activities will be allocated between 2022 and 2023; three indicators have reached their targets and are in the process of being disbursed. It is worth noting that five indicators from the 13 are new indicators that were added as part of the AF, which became effective on August 4, 2021.


