## 4. KEY ISSUES & STATUS

### 4.1 Implementation Status and Key Decisions

Phase I of the Sava and Drina Rivers Corridors Integrated Development Program Multi-Phase Programmatic Approach (MPA) is progressing with the implementation of several project activities in all participating countries. In Serbia, several civil works contracts in Jarak and Novi Pazar are underway and new contracts, including for the preparation of technical documentation for flood protection of the town of Obrenovac have been signed. The preparation of the bidding process for the modernization of the port of Sremska Mitrovica is ongoing. In Montenegro, civil works for flood protection of the Lim river in Berane and Bijelo Polje are progressing, and other investments are under preparation. In Bosnia and Herzegovina, the ratification process of the grant for demining of the right bank of the Sava river was approved in December 2024 and can soon be implemented. In the Republika Srpska, civil works for the rehabilitation of the Grand Circumference Canal (GOK) are underway, as are the examination of the Sava and Una dykes and forestry related activities. Several other investments are under preparation. The Additional Financing (AF) for the Federation of BiH and for Brcko District is effective and implementation of activities is being initiated. The ISRBC has signed a contract for the Joint Statement 2.0, other contracts continue under preparation. Discussions on potential investments for Phase 2 of the MPA have been discussed and the process for preparation of Phase 2 is ongoing by the member countries.


