Nepal: Second Bridge Improvement and Maintenance Program (IDA Cr. 6317-NP) Amendment to the Financing Agreement

We refer to the Financing Agreement ("Financing Agreement") between Nepal ("Recipient") and International Development Association ("Association") dated November 14, 2018, as amended, for the Second Bridge Improvement and Maintenance Program ("Program"). We also refer to the letter from the Recipient dated February 15, 2024, requesting reallocation of the proceeds of the Credit.

The Association proposes to amend the Financing Agreement as follows:

- 1. The definition for the term "Program Expenditures" in the Appendix is substituted to read as follows:
 - "Program Expenditures" means, for purpose of, inter alia, Sections 2.03 and 8.06 of the General Conditions, the payments for goods, works, services and salaries made under the following budget sub-heads or any corresponding budget sub-heads replaced and/or changed by the government, and any other budget sub-heads agreed in writing by the Association:
 - 33701108 Madan Bhandari Highway (From Bahundangi to Rupal)
 - 33701128 Postal Highway (Including Bridges)
 - 33701114 Pushpalal Highway (Mid-Hill Highway)
 - 33701125 Mahakali Bridge Project
 - 33701132 Bridge Construction and Maintenance under Strategic Road Network (SRN)
- 2. The withdrawal table in Section IV.A.1 of Schedule 2 has been revised as set forth in Attachment 1 to this letter.

Except as specifically amended in this amendment letter, all other provisions of the Financing Agreement shall remain unchanged and in full force and effect.

Please confirm your agreement to the foregoing on behalf of Recipient by countersigning and dating the corresponding form of confirmation set forth below and returning one fully countersigned original of this amendment letter to the Association. The above amendment to the Financing Agreement shall become effective upon receipt by the Association of the duly countersigned copy of this amendment letter.
