Women, Business and the Law in Mexico

Women, Business and the Law (WBL) 2023 presents an index covering 190 economies, structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. Mexico scores 89 out of 100, while the regional average across Latin America and Caribbean is 81 .
