#### I. PROJECT STATUS AND RATIONALE FOR RESTRUCTURING

- 1. This Project Paper seeks approval of the Country Director for restructuring the Bangladesh Health Sector Support Project (HSSP) to amend the legal agreements for the reasons stated below. HSSP is co-financed by IDA (Cr. 6127-BD, Cr. 6302-BD, Grant D361-BD), Global Financing Facility (GFF, TF0A4355) grant, and a Multi-Donor Trust Fund (MDTF, TF0A6941) grant.
  - a. Process a no-cost extension of the project closing date by six months from December 31, 2023, to June 30, 2024, for:
    - i. IDA proceeds (6127-BD, 6302-BD, and D3610) and
    - ii. HSSP-MDTF (TF0A6941).
    - iii. The GFF grant is not being extended as the remaining balance (6% of the total commitment) will be fully disbursed by the current closing date of September 30, 2023.
  - b. Revise the target for one of the disbursement-linked result (DLR 4.2 from 30 district hospitals to 14 district hospitals) for IDA Cr. 6127-BD.
  - c. Reallocate GFF proceeds (TF0A4355) between existing DLRs.
- 2. **Project Background:** The HSSP uses the investment project financing (IPF) instrument with performance-based conditions (PBCs) (formerly Disbursement-Linked Indicators [DLIs]). The project was approved by the World Bank Board in July 2017 with an allocation of US\$500 million equivalent International Development Association (IDA) credit and US\$15 million grant from the Global Financing Facility (GFF). Five development partners (Canada, the Netherlands, Sweden, the United Kingdom, and Gavi, The Vaccine Alliance) are co-financing the project through the HSSP-MDTF, disbursing against the same set of DLIs that are being financed by IDA and GFF. In June 2018, a fourth component was added to HSSP (which does not include DLIs) to mobilize additional IDA financing of US\$50 million equivalent (US\$41.67 million IDA grant and US\$8.33 million IDA credit) to assist the government in responding to the crisis posed by an influx of displaced Rohingya population from Myanmar. The fourth component is not supported by the HSSP-MDTF and GFF proceeds. The HSSP is implemented by the Ministry of Health and Family Welfare (MoHFW) and supports its national sector program for 2017–2024. The PDO is to strengthen the health, nutrition and population (HNP) sector's core management systems and delivery of essential HNP services with a focus on selected geographical areas.
- 3. Progress towards achievement of the PDO and implementation progress are rated as satisfactory. The project is also rated satisfactory with respect to its performance in financial management, procurement, and safeguards. There are no pending audit reports. Out of the seven PDO indicators, five have achieved the end-of-project targets and the remaining

two are on track. Eighty-three percent of planned annual targets, or DLRs under components 1 to 3, have been reported to be achieved during the first five years since the program has started.

4. The proposed restructuring responds to a request received from the Economic Relations Division of the Ministry of Finance, dated January 26, 2023. The changes proposed in this paper have been discussed and agreed with the MoHFW during the HSSP implementation support mission between November 28 to December 08, 2022, as documented in the aide-mémoire. For the HSSP-MDTF, the administration agreements between the World Bank and the five contributing partners have been amended to reflect the revised closing date. These amendments took time to complete as the partners had to process their internal clearances.

#### **II. DESCRIPTION OF PROPOSED CHANGES**

- 5. **Extension of the project closing date:** As mentioned above, HSSP is co-financed by IDA (Cr. 6127-BD, Cr. 6302-BD, Grant D361-BD), Global Financing Facility (GFF, TF0A4355) grant, and MDTF (TF0A6941) grant. HSSP mobilizes resources to the government's Fourth Health, Population and Nutrition Sector Program (4<sup>th</sup> HPNSP). The closing date of the HPNSP is being extended by one-year from June 30, 2023, to June 30, 2024, to allow sufficient time for preparation of the follow-on 5<sup>th</sup> Sector Program to be completed and thereby ensuring no interruption of services in the field. Consequently, the HSSP closing date is proposed to be extended by six months up to June 30, 2024 (for IDA and HSSP-MDTF), to synchronize with the implementation timeline for the 4<sup>th</sup> Sector Program and allow sufficient time for the remaining DLRs to be achieved and verified to enable disbursement of project funds. This is the second no-cost extension of the closing date by 18 months cumulative from the original closure of December 31, 2022. The GFF grant (TF0A4355) is 94% disbursed (US\$14.1 million disbursed against the total grant of US\$15 million) and the remaining 6% (around US\$0.9 million) will be disbursed by the current closing date of September 30, 2023.
- 6. **Modification to the target for DLR 4.2 for IDA 6127-BD:** Progress with achievement of DLR 4.2 (asset management system is implemented in district hospitals) has been slow due to lack of clarity regarding definition of assets. During the November 2022 mission, the definition was further clarified as documented in the aide-mémoire. With only one year left of the implementation period, the target of DLR 4.2 (for IDA Cr. 6127-BD) is being revised from 30 district hospitals to 14 district hospitals (cumulative).
- 7. **Reallocation of GFF proceeds (TF0A4355) between existing DLRs**: as mentioned above, US\$14.1 million out of the total grant of US\$15 million, or 94%, has been disbursed. To ensure the remaining balance of US\$0.9 million is disbursed by the current closing date of September 30, 2023, the following reallocation is being proposed:

8. **Modification of the HSSP MDTF grant agreement (TF0A6941):** the grant agreement for the HSSP MDTF will be modified to increase the total grant amount from US\$120.3 million to US\$131.1 million. This increase of US\$10.8. million is based on planned tranches received from the MDTF partners, as documented in the administration agreements, and is allocated for the same set of DLRs as financed by IDA (Cr. 6127-BD). This modification does not require project restructuring as the original HSSP project was approved by the World Bank Board with a financing gap of US\$200 million, which this MDTF is filling.
