LOAN AGREEMENT

AGREEMENT dated as of the Signature Date between INDIA ("Borrower") and INTERNATIONAL BANK FOR RECONSTRUCTION AND DEVELOPMENT ("Bank"). The Borrower and the Bank hereby agree as follows:

ARTICLE I — GENERAL CONDITIONS; DEFINITIONS

- 1.01. The General Conditions (as defined in the Appendix to this Agreement) apply to and form part of this Agreement.
- 1.02. Unless the context requires otherwise, the capitalized terms used in this Agreement have the meanings ascribed to them in the General Conditions or in the Appendix to this Agreement.

ARTICLE II — LOAN

- 2.01. The Bank agrees to lend to the Borrower the amount of three hundred and sixty-three million Dollars (\$363,000,000), as such amount may be converted from time to time through a Currency Conversion ("Loan"), to assist in financing the program described in Schedule 1 to this Agreement ("Program").
- 2.02. The Borrower may withdraw the proceeds of the Loan in accordance with Section III of Schedule 2 to this Agreement. All withdrawals from the Loan Account shall be deposited by the Bank into an account specified by the Borrower and acceptable to the Bank.
- 2.03. The Front-end Fee is one quarter of one percent (0.25%) of the Loan amount.
- 2.04. The Commitment Charge is one quarter of one percent (0.25%) per annum on the Unwithdrawn Loan Balance.
- 2.05. The interest rate is the Reference Rate plus the Variable Spread; or such rate as may apply following a Conversion; subject to Section 3.02(e) of the General Conditions.
- 2.06. The Payment Dates are March 15 and September 15 in each year.
- 2.07. The principal amount of the Loan shall be repaid in accordance with Schedule 3 to this Agreement.

ARTICLE III — PROGRAM

3.01. The Borrower declares its commitment to the objectives of the Program. To this end, the Borrower shall cause the Program to be carried out by the Program Implementing Entity in accordance with the provisions of Article V of the General Conditions, Schedule 2 to this Agreement and the Program Agreement.

ARTICLE IV — EFFECTIVENESS; TERMINATION

4.01. The Effectiveness Deadline is the date ninety (90) days after the Signature Date.

ARTICLE V — REPRESENTATIVE; ADDRESSES

SCHEDULE 1

Program Description

The objective of the Program is to increase access to safely managed drinking water and strengthen institutions for sustainable rural water service delivery in Karnataka.

The Program consists of the following activities:

Result Area 1: Increase access to safely managed rural water supply

- (a) Support metered functional household tap connections through new and rehabilitated invillage water infrastructure.
- (b) Strengthen citizen engagement through: (i) participatory planning and appraisal through social audits; (ii) undertake information, education, and communication (IEC) activities; and (iii) strengthen the Program's grievance redressal mechanism and extend grievance redressal mechanisms to the tank rejuvenation works.

Result Area 2: Strengthen institutions, policies, and finance to improved sustainability of water services

- (a) Support the notification and operationalization of the O&M Policy to enable the sustainability of rural water supply schemes.
- (b) Support the development and institutionalization of a set of performance criteria at the GP level to improve service delivery and sustainability of the water infrastructure.
- (c) Support the expansion in the functionalities of the sector monitoring system to enable RDWSD to remotely monitor activities including GP specific revenue generation, O&M budgets and VWSC activities.
- (c) Support the state in (i) modernizing its Water Quality Monitoring Information System (WQMIS) and data governance architecture to make water quality data accessible to policy makers and citizens and (ii) enhancing water quality testing through setting up of laboratories with relevant accreditation to ensure that national standards are conformed and prioritizing microbiological testing capacity.
- (d) Provide training in leadership development through the roll-out of a field-level leadership initiative to RDWSD staff and state districts officials relevant for the Program.
- (e) Build capacity for technical assessment and social behavior change activities to support the roll-out of 24/7 water supply service.
- (f) Incentivize sustainability of GPs by establishing the technical, social, and financial sustainability criteria to be satisfied by them.
- (g) Support increased participation and representation of women in technical jobs.

Results Area 3: Improve water source sustainability and energy efficiency to enhance climate resilience

- (a) Support the development of a Water Policy Implementation Roadmap.
- (b) Support reduction in energy expenditure and carbon footprint through (i) energy audits and the implementation of the energy audit recommendations; (ii) a scoping study on public-private partnership models for solar energy and training to engineers on solar water pumping.
- (c) Support tank rejuvenation and its O&M to increase water storage in Select Districts to accelerate groundwater recharge.

SCHEDULE 2

Program Execution

Section I. Implementation Arrangements

A. Program Institutions

- 1. To facilitate the carrying out of the Program by the Program Implementing Entity, the Borrower shall make the proceeds of the Loan available to the Program Implementing Entity in accordance with the Borrower's standard arrangements for developmental assistance to the states of India. Notwithstanding the foregoing, in the event that any provision of this Agreement, including the instructions that the Bank shall have specified by notice to the Borrower pursuant to Section III.A of this Schedule 2, were to be found inconsistent with the Borrower's standard arrangements for development assistance to the states of India, the provisions of this Agreement and aforesaid instructions shall govern.
- 2. The Borrower shall at all times protect its own interests and the interests of the Bank to accomplish the purposes of the Loan.

B. Program Action Plan

1. The Borrower shall cause the Program Implementing Entity to implement the Program Action Plan, in accordance with the provisions of Section I.C of the Schedule to the Program Agreement.

Section II. Program Monitoring, Reporting and Evaluation

A. Program Reports

- 1. The Borrower shall cause the Program Implementing Entity to furnish to the Bank each Program Report not later than forty-five days after the end of each calendar semester, covering the calendar semester.
- 2. By no later than September 30, 2025 or such other period as may be agreed with the Bank, the Borrower together with the Program Implementing Entity shall jointly with the Bank carry out one (1) mid-term review of the Program to assess the status of the Program implementation, as measured against the indicators and results framework agreed with the Bank and the legal covenants included/referred to in this Agreement and/or the Program Agreement, and shall incorporate the findings of such review into the Program design for the subsequent years and take all such measures necessary for the efficient completion of the Program based on the recommendations of the review and the Bank's views on the matter.

B. Verification Protocol

The Borrower shall cause the Program Implementing Entity to:

(a) appoint within 1 (one) month from the Effective Date and maintain at all times during the implementation of the Program, an independent verification agent under terms of

- reference and qualifications acceptable to the Bank ("Independent Verification Agent"), to verify the evidence supporting the achievement of one or more DLRs and certify the fulfillment of such DLRs as set forth in Schedule 4 to this Agreement; and
- (b) ensure that the Independent Verification Agent carries out verification processes in accordance with the Verification Protocols and furnish to the Bank the corresponding verification reports in form and substance satisfactory to the Bank.

Section III. Withdrawal of Loan Proceeds

A. General

- 1. Without limitation upon the provisions of Article II of the General Conditions and in accordance with the Disbursement and Financial Information Letter, the Borrower may withdraw the proceeds of the Loan to: (a) finance Program Expenditures (inclusive of Taxes), on the basis of the results ("Disbursement Linked Results" or "DLRs") achieved by the Program Implementing Entity, as measured against specific indicators ("Disbursement Linked Indicators" or "DLIs"); and (b) pay: (i) the Front-end Fee; and (ii) pay each Interest Rate Cap or Interest Rate Collar premium; all as set forth in the table in paragraph 2 of this Part A and Schedule 4 to this Agreement.
- 2. The following table specifies each category of withdrawal of the proceeds of the Loan (including the Disbursement Linked Indicators as applicable) ("Category"), and the allocation of the amounts of the Loan to each Category; provided that for the purpose of Categories (1) to (8) of the table below, the actual amount authorized for disbursement ("Allocated Amount") based on the formula for its determination upon the achievement of an individual DLR for any given DLI financed under such Category, shall be calculated as set forth in Schedule 4 to this Agreement:

B. Withdrawal Conditions; Withdrawal Period

- 1. Notwithstanding the provisions of Part A of this Section, no withdrawal shall be made:
 - (a) under Categories (1) to (8) on the basis of DLRs achieved prior to the Signature Date, except that withdrawals up to an aggregate amount not to exceed \$90,000,000 may be made on the basis of DLRs achieved under Categories (1) to (8) prior to this date but on or after September 9, 2022; or/and
 - (b) under Categories (1) to (8) for any DLR, until and unless the Borrower has furnished evidence satisfactory to the Bank that said DLR has been achieved.
- 2. Notwithstanding the provisions of Part B.1(b) of this Section, if any of the DLRs under Category (1) to (8) has not been achieved by the date by which the said DLR is set to be achieved (or such later date as the Bank has established by notice to the Borrower), the Bank may, by notice to the Borrower: (a) authorize the withdrawal of such lesser amount of the unwithdrawn proceeds of the Loan then allocated to said Category which, in the opinion of the Bank, corresponds to the extent of achievement of said DLR, said lesser amount to be calculated in accordance with the formula set out in out in Schedule 4 to this Agreement; (b) reallocate all or a portion of the proceeds of the Loan then allocated to said DLR to any other DLR; and/or (c) cancel all or a portion of the proceeds of the Loan then allocated to said DLR; and/or (d) authorize the withdrawal of such portion of the Allocated Amount which has not been disbursed by the expected date pursuant to paragraph (a) immediately above, at a later than the expected date for the DLR(s) achieved after such initially expected date, provided that achievement occurs not later than the Closing Date.
- 3. The Closing Date is June 1, 2028.

APPENDIX

Section I. Definitions

- 1. "Allocated Amount" means the amount allocated to each individual DLR, or determined for each DLR pursuant to the formula detailed in the table in Schedule 4 to this Agreement, as such amount might be increased, reallocated and/or cancelled (whether partially or in its entirety) by the Bank, from time to time, as the case may be, in accordance with the provisions of Section III.B.2 of Schedule 2 to this Agreement.
- 2. "Anti-corruption Guidelines" means, for purposes of paragraph 6 of the Appendix to the General Conditions, the Bank's "Guidelines on Preventing and Combating Fraud and Corruption in Program-for-Results Financing," dated February 1, 2012, and revised July 10, 2015.
- 3. "Category" means a category set forth in the table in Section III.A.2 of Schedule 2 to this Agreement.
- 4. "Disbursement Linked Indicator" or "DLI" means in respect of a given Category, the indicator related to said Category as set forth in the table in Section III.A.1 of Schedule 2 to this Agreement.
- 5. "Disbursement Linked Result" or "DLR" means in respect of a given Category, the result under said Category as set forth in the table in Schedule 4 of this Agreement, on the basis of the achievement of which, the amount of the Loan allocated to said result may be withdrawn in accordance with the provisions of said Section III.A.1 of Schedule 2 to this Agreement.
- 6. "FHTC" means functional household tap connections meeting the criteria as specified in the Program Operations Manual.
- 7. "Fiscal Year" or "FY" means the Borrower's fiscal year, which begins on April 1 of each calendar year and ends on March 31 of the next calendar year.
- 8. "General Conditions" means the "International Bank for Reconstruction and Development General Conditions for IBRD Financing, Program-for-Results Financing", dated December 14, 2018 (revised on August 1, 2020, December 21, 2020, April 1, 2021, and January 1, 2022.
- 9. "Gram Panchayat" or "GP" means the basic unit of local self-government established under the Karnataka Gram Swaraj and Panchayat Act, 1993 as amended from time to time.
- 10. "Independent Verification Agent" means the independent entity (or entities) to be engaged by the Program Implementing Entity for the purposes of certifying the achievement of the DLRs as referred to in Section III.B of Schedule 2 to this Agreement.
- 11. "Karnataka" means the Borrower's State of Karnataka.
- 12. "M&E" means monitoring and evaluation.

- 13. "O&M Policy" means policy statements on (a) water source, (b) water infrastructure, (c) finance, (d) human resources and (e) governance cum institutional components, and strategic actions to operationalize the policies for rural water supply in Karnataka to be drafted and issued by RDWSD.
- 14. "Program Action Plan" means the Program Implementing Entity's plan dated February 21, 2023 and referred to in Section 1.B of Schedule 2 to this Agreement and Section I.C of the Schedule to the Program Agreement, as may be amended from time to time with the agreement of the Bank.
- 15. "Program Implementation Committee" or "PIC" means the committee to be established by RDPR and referred to in Section I.B.1 of the Schedule 1 to the Program Agreement.
- 16. "Program Implementing Entity" means the Borrower's state of Karnataka.
- 17. "Program Management Unit" or "PMU" means the unit to be established by RDWSD and referred to in Section I.B.1 of the Schedule 1 to the Program Agreement.
- 18. "Program Operations Manual" means the manual to be prepared by the Program Implementing Entity through the DoE and adopted by the Implementing Agencies in a manner and substance satisfactory to the Bank for the purposes of carrying out the Program, which manual shall comprise of, *inter alia*: (i) the scope of the Program activities and the Program expenditures; (b) the Program implementation arrangements including fiduciary and safeguards; (c) the Program's monitoring and evaluation, and reporting requirements and the Verification Protocol; and (d) actions required in order to operationalize the implementation of the Anti-corruption Guidelines, as such manual may be amended from time to time with the prior written concurrence of the Bank.
- 19. "Program Steering Committee" or "PSC" means the committee to be established by RDPR and referred to in Section I.B.1 of the Schedule 1 to the Program Agreement.
- 20. "RDPR" means the Program Implementing Entity's Rural Development and Panchayat Raj, or its successor thereto.
- 21. "RDWSD" means the Program Implementing Entity's Rural Drinking Water and Sanitation Department, or its successor thereto.
- 22. "Select Districts" means the water-stressed districts of Bengaluru Rural, Bengaluru Urban, Bidar, Chikkaballapura, Kalaburgi, Kolara, and Tumakuru.
- 23. "Signature Date" means the later of the two dates on which the Borrower and the Bank signed this Agreement and such definition applies to all references to "the date of the Loan Agreement" in the General Conditions.
- 24. "Verification Protocol" means the Program Implementing Entity's protocol as set forth in the Program Operations Manual, acceptable to the Bank, setting forth the means by which the achievement of DLRs will be verified under the Program, as such Verification Protocol may be amended from time to time with the prior written agreement of the Bank.

- 25. "VWSC" means the village water sanitation committee constituted at the GP level for each GP in the State to manage the water supply management at the village level.
- 26. "Water Policy Implementation Roadmap" means the roadmap to be adopted by the Program Implementing Entity to support the long-term planning and decision-making for water security in the state.
- 27. "Water Quality Monitoring Information System" or "WQMIS" means the web-portal developed by the Program Implementing Entity to report water quality test details.
- 28. "Year 1" means the first year of implementation of Program activities, which have taken place in the Borrower's Fiscal Year 2023-24.
- 29. "Year 2" means the second year of implementation of Program activities, which have taken place in the Borrower's Fiscal Year 2024-25.
- 30. "Year 3" means the third year of implementation of Program activities, which have taken place in the Borrower's Fiscal Year 2025-26.
- 31. "Year 4" means the fourth year of implementation of Program activities, which have taken place in the Borrower's Fiscal Year 2026-27.
- 32. "Year 5" means the fifth year of implementation of Program activities, which have taken place in the Borrower's Fiscal Year 2027-28.
- 33. "Year" means any of the Years 1 through 5 of Program implementation, as the context shall determine.
