FINANCING AGREEMENT

AGREEMENT dated as of the Signature Date between the ISLAMIC REPUBLIC OF MAURITANIA ("Recipient") and the INTERNATIONAL DEVELOPMENT ASSOCIATION ("Association") for the purpose of assisting in financing the project described in Schedule 1 to this Agreement ("Project").

WHEREAS:

- A. the Participating Countries and the Regional Bodies, including the Recipient, have agreed to participate in the Project;
- B. the Recipient, having satisfied itself as to the feasibility and priority of the Project, has requested the Association to assist in the financing of the Project;
- C. by a financing agreement to be entered into on or about the date hereof between the Republic of Benin and the Association (the "Benin Financing Agreement"), the Association will extend to Benin financing to assist Benin in financing part of the cost of activities related to the Project on the terms and conditions set forth in the Benin Financing Agreement;
- D. by a financing agreement to be entered into on or about the date hereof between the Republic of The Gambia and the Association (the "Gambia Financing Agreement"), the Association will extend to The Gambia financing to assist The Gambia in financing part of the cost of activities related to the Project on the terms and conditions set forth in the Gambia Financing Agreement;
- E. by a financing agreement to be entered into on or about the date hereof between the Republic of Guinea and the Association (the "Guinea Financing Agreement"), the Association will extend to Guinea financing to assist Guinea in financing part of the cost of activities related to the Project on the terms and conditions set forth in the Guinea Financing Agreement;
- F. by a financing agreement to be entered into on or about the date hereof between the Republic of Guinea-Bissau and the Association (the "Guinea-Bissau Financing Agreement"), the Association will extend to Guinea-Bissau financing to assist Guinea-Bissau in financing part of the cost of activities related to the Project on the terms and conditions set forth in the Guinea-Bissau Financing Agreement;
- G. by a financing agreement to be entered into on or about the date hereof between the Republic of Mali and the Association (the "Mali Financing Agreement"), the Association will extend to Mali financing to assist Mali in financing part of the cost of activities related to the Project on the terms and conditions set forth in the Mali Financing Agreement;

- H. by a financing agreement to be entered into on or about the date hereof between the Republic of Niger and the Association (the "Niger Financing Agreement"), the Association will extend to Niger financing to assist Niger in financing part of the cost of activities related to the Project on the terms and conditions set forth in the Niger Financing Agreement;
- I. by a financing agreement to be entered into on or about the date hereof between the Republic of Senegal and the Association (the "Senegal Financing Agreement"), the Association will extend to Senegal financing to assist Senegal in financing part of the cost of activities related to the Project on the terms and conditions set forth in the Senegal Financing Agreement;
- J. by a financing agreement to be entered into on or about the date hereof between the African Union and the Association (the "AU Financing Agreement"), the Association will extend to African Union financing to assist African Union in financing part of the cost of activities related to the Project on the terms and conditions set forth in the AU Financing Agreement;
- K. by a financing agreement to be entered into on or about the date hereof between ECOWAS and the Association (the "ECOWAS Financing Agreement"), the Association will extend to ECOWAS financing to assist ECOWAS in financing part of the cost of activities related to the Project on the terms and conditions set forth in the ECOWAS Financing Agreement;
- L. by a financing agreement to be entered into on or about the date hereof between WAEMU and the Association (the "WAEMU Financing Agreement"), the Association will extend to WAEMU financing to assist WAEMU in financing part of the cost of activities related to the Project on the terms and conditions set forth in the WAEMU Financing Agreement;
- M. Parts 1.1.1 and 4.1 of the Project will be implemented by the African Union;
- N. Parts 1.1.2 and 4.1 of the Project will be implemented by ECOWAS;
- O. Parts 1.1.3, 2.3(c) and 4.1 will be implemented by WAEMU;
- P. Parts 1.2.2, 1.2.3, 1.3.1, 1.3.2(b), (c) and (d), 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2(b) and (c), 2.3(a) and (b), 2.4, 2.5(d), 3.2, 4.1, 4.2 will be implemented by Benin;
- Q. Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2, 1.3.3, 1.4.1, 1.4.2, 1.5.1, 2.1, 2.2, 2.3(a) and (b), 2.4(a) and (b), 2.5, 3.1(b) and (c), 3.2, 4.1, 4.2 will be implemented by The Gambia;

- R. Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2(b), (c) and (d), 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2, 2.3, 2.4(a) and (b), 2.5(a), (b) and (d), 3.1(c), 3.2, 4.1, 4.2 will be implemented by Guinea;
- S. Parts 1.2.1, 1.2.2(a) and (c), 1.2.3, 1.3.1, 1.3.2, 1.3.3, 1.4.1, 1.4.2, 1.5.1, 2.1, 2.2, 2.3(a) and (b), 2.4(a) and (b), 2.5(a), (c) and (d), 3.2, 4.1, 4.2 will be implemented by Guinea-Bissau;
- T. Parts 1.2.2, 1.2.3, 1.3.1, 1.3.2(b) and (d), 1.3.3, 1.4.1, 1.5.1, 2.1, 2.2, 2.3, 2.4(a) and (b), 2.5(a), (b) and (d), 3.2, 4.1, 4.2 will be implemented by Mali;
- U. Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2, 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2, 2.3, 2.4, 2.5(a), (c) and (d), 3.1(a) and (c), 3.2, 4.1, 4.2 will be implemented by the Recipient;
- V. Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2(b), (c) and (d), 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2, 2.3, 2.4(a) and (b), 2.5(a), (b) and (d), 3.1(a) and (c), 3.2, 4.1, 4.2 will be implemented by Niger; and
- W. Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2(b), (c) and (d), 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2(b) and (c), 2.3, 2.4(a) and (b), 2.5(a), (b) and (d), 3.1(a), 3.2, 4.1, 4.2 will be implemented by Senegal.

WHEREAS the Association has also agreed, on the basis, *inter alia*, of the foregoing, to extend the financing provided for in Article II of this Agreement to the Recipient upon the terms and conditions set forth in this Agreement.

NOW THEREFORE the Recipient and the Association hereby agree as follows:

ARTICLE I — GENERAL CONDITIONS; DEFINITIONS

- 1.01. The General Conditions (as defined in the Appendix to this Agreement) apply to and form part of this Agreement.
- 1.02. Unless the context requires otherwise, the capitalized terms used in this Agreement have the meanings ascribed to them in the General Conditions or in the Appendix to this Agreement.

ARTICLE II — FINANCING

2.01. The Association agrees to extend to the Recipient a credit, which is deemed as Concessional Financing for purposes of the General Conditions, in an amount equivalent to thirty-three million nine hundred thousand Special Drawing Rights (SDR 33,900,000) (variously, "Credit" and "Financing"), to assist in financing the project described in Schedule 1 to this Agreement ("Project").

- 2.02. The Recipient may withdraw the proceeds of the Financing in accordance with Section III of Schedule 2 to this Agreement.
- 2.03. The Maximum Commitment Charge Rate is one-half of one percent (1/2 of 1%) per annum on the Unwithdrawn Financing Balance.
- 2.04. The Service Charge is three-fourths of one percent (3/4 of 1%) per annum on the Withdrawn Credit Balance.
- 2.05. The Interest Charge is one and a quarter percent (1.25%) per annum on the Withdrawn Credit Balance
- 2.06. The Payment Dates are April 15 and October 15 in each year.
- 2.07. The principal amount of the Credit shall be repaid in accordance with the repayment schedule set forth in Schedule 3 to this Agreement.
- 2.08. The Payment Currency is Dollar.

ARTICLE III — PROJECT

3.01. The Recipient declares its commitment to the objective of the Project. To this end, the Recipient shall cause Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2, 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2, 2.3, 2.4, 2.5(a), (c) and (d), 3.1(a) and (c), 3.2, 4.1, 4.2 of the Project to be carried out by the Project Implementing Entity ("PIE") in accordance with the provisions of Article V of the General Conditions and Schedule 2 to this Agreement and the Project Agreement.

ARTICLE IV — REMEDIES OF THE ASSOCIATION

- 4.01. The Additional Events of Suspension consist of the following:
 - (a) The AU Financing Agreement shall have failed to become effective by December 31, 2024.
 - (b) The ECOWAS Financing Agreement shall have failed to become effective by December 31, 2024.
 - (c) The WAEMU Financing Agreement shall have failed to become effective by December 31, 2024.
 - (d) The Association shall have suspended in whole or in part the right of the AU, ECOWAS or WAEMU, as the case may be, to make withdrawals, respectively, under the AU Financing Agreement, the ECOWAS Financing Agreement or the WAEMU Financing Agreement.

4.02. The Additional Event of Acceleration consists of the following, namely that any event specified in Section 4.01 of this Agreement occurs and is continuing for a period of sixty (60) days after notice of the event has been given by the Association to the Recipient.

ARTICLE V — EFFECTIVENESS; TERMINATION

- 5.01. The Additional Conditions of Effectiveness consists of the following:
 - (a) The Subsidiary Agreement has been duly executed and delivered on behalf of the Recipient and the PIE under terms and conditions acceptable to the Association, and such Subsidiary Agreement shall have become effective and binding upon the parties in accordance with its terms.
 - (b) The Recipient, through the PIE, shall have adopted the Project Operations Manual under terms and conditions acceptable to the Association.
 - (c) The Recipient, through the PIE, shall have: (i) established the Project Implementation Unit for the Project, in accordance with Section I.A.1 of Schedule 2 to this Agreement; and (ii) recruited a Project coordinator, a procurement specialist and a financial management specialist, all with terms of reference, qualifications and experience, and under terms and conditions acceptable to the Association.
 - (d) The Recipient shall have prepared, disclosed, consulted upon and adopted: (i) the Umbrella Environmental and Social Management Framework ("U-ESMF"); and (ii) the Umbrella Labor Management Procedures Framework ("U-LMPF"); all in accordance with the ESCP, and in form and substance satisfactory to the Association.
- 5.02. The Effectiveness Deadline is the date one hundred and twenty (120) days after the Signature Date.
- 5.03. For purposes of Section 10.05 (b) of the General Conditions, the date on which the obligations of the Recipient under this Agreement (other than those providing for payment obligations) shall terminate is twenty (20) years after the Signature Date.

ARTICLE VI — REPRESENTATIVE; ADDRESSES

- 6.01. The Recipient's Representative is its minister in charge of economy.

SCHEDULE 1

Project Description

The objective of the Project is to improve country statistical performance, regional harmonization, data access and use, and to enhance modernization of the statistical system in Participating Countries.

The Project consists of the following parts:

Part 1. Harmonization and Production of Core Statistics Using International Data Quality Standards

1.1. Regional Coordination and Adoption of Harmonized Data Quality Standards

Supporting Regional Bodies to improve quality and comparability of statistics and enhance their statistical advocacy and coordination, through:

- **1.1.1. African Union-STATAFRIC.** Supporting STATAFRIC in advocating and monitoring the implementation of SHaSA2 through: (a) coordination with regional economic communities on standard harmonization, statistics comparability and dissemination, by providing technical assistance, regional workshops and Training to Participating Countries; (b) Training on national and regional strategy for the development of statistics in collaboration with other partners; (c) monitoring compliance by Participating Countries of SHaSA2; and (d) work with development partners to mobilize financing and technical assistance.
- 1.1.2. ECOWAS. Supporting ECOWAS to: (a) intensify regional statistical harmonization through the consolidation of production, analysis and dissemination of data; (b) advocate and monitor the implementation of Regional Statistical Program 2023-2027; (c) organize Training on NSDS strategic planning in collaboration with other partners; (d) monitor compliance by Participating Countries of said Regional Statistical Program; (e) work with development partners to mobilize financing and provide technical assistance; and (f) provide relevant technical assistance, peer-to-peer learning and support to Participating Countries on statistics.
- **1.1.3. WAEMU.** Supporting WAEMU in coordinating, *inter alia*: (a) the renovation of national accounts of the Participating Countries that are members to WAEMU; (b) the conduct of labor force and household living conditions surveys; (c) relevant Training, technical studies and outreach activities; and (d) support to regional statistical schools.

1.2. Demographic and Socio-Economic Statistical Production

Support selected Participating Countries in producing updated demographic and socioeconomic data, through:

- **1.2.1. Population and Housing Census.** Supporting all phases of population and housing censuses activities including *inter alia:* (a) pilot cartography and census; (b) main cartography; (c) enumeration; (d) post enumeration survey; (e) data processing and analysis; as well as (f) census results and data dissemination.
- **1.2.2. Integrated Household Survey Program.** Supporting integrated household survey programs through financing of *inter alia*: (a) demographic and health surveys; (b) labor force surveys; and (c) household income and expenditure surveys; and/or as needed, ondemand ad hoc surveys; with a specific focus on harmonized and standardized methodologies and use of new technologies in data collection, and climate-sensitive statistics.
- **1.2.3. Gender.** Filling gender data gaps and improving gender statistics through (a) implementation and improvement of data collection efforts and (b) capacity-building activities to enhance data collection, indicator calculation, and data dissemination.

1.3. Real and Fiscal Sector Statistical Production

Improving the Consumer Price Index (CPI) and national accounts statistics, by supporting: (a) the implementation of the latest government finance statistical performance standards; and (b) the improvement of data dissemination standards, through:

- **1.3.1. Source Data Collection and Adoption of Improved National Accounts Standards.** Supporting Participating Countries to: (a) improve source data used to compile national accounts, especially strengthening enterprise statistics including building and maintaining business census and registers, annual or biennial surveys, and an electronic platform to collect statistical and tax declaration data; and (b) complete the rebasing cycle of national accounts, including *inter alia* through standardized and/or expanded data collection in selected sectors or indicators, production or improvement of quarterly national accounts, enhanced periodicity or subnational scope, depending on identified needs in Participating Countries.
- **1.3.2. Modernization and Adoption of Improved CPI Standards.** Improving quality and timeliness of CPI, including by supporting Participating Countries to: (a) modernize price collection processes through technology

- and acceptable harmonized methodologies and standards; (b) rebase CPI base years; (c) align with international standards; and (d) extend geographical coverage of the CPI.
- **1.3.3. Improved Government Finance Statistics Standards.** Financing technical assistance, regional Training and peer learning to support Participating Countries in adopting and implementing the most recent international standards and practices on government finance statistics, including as needed at the subregional or decentralized level.

1.4. Agricultural and Climate Change Statistical Production

- 1.4.1. Implementation of an Integrated System of Agricultural Sample Censuses and Surveys. Improving and conducting annual or periodical agriculture sample censuses and surveys and design and implementation of livestock data collection in Participating Countries through financing of costs associated with data collection, technical tools and Training.
- **1.4.2. Geo-spatial, Remote Sensing and Climate Data Collection.** Strengthening the capacity of NSOs to advance in the collection and production of core climate change statistics and indicators (including geospatial data), based on international standards, through financing of costs associated with data collection and production, technical assistance and Training to identify a minimum set of climate change indicators to be produced and collected.

1.5. Sectoral and Sub-National Administrative Data Curation

Improve quality and availability of data from administrative sources and support production and dissemination of administrative data, including at the subnational level, through:

- **1.5.1. Improved Sectoral Administrative Data Systems and Integration.** Providing technical assistance and Training to NSOs on the design of administrative data collection and processing of *inter alia* health, education and other administrative data using international standards and modern processing tools and techniques.
- **1.5.2. Production and Management of Sub-National Statistics.** Strengthening the capacities at the decentralized level of NSOs to perform data collection, production, and dissemination, as well as subnational statistical coordination, also through financing of needed goods, Operating Costs and Training.

Part 2. Statistical Modernization, Institutional Reform, Human Capital, Data Accessibility and Use

2.1. Statistical Modernization of National Statistical Offices.

Supporting Participating Countries in the production of statistics using new data sources and collection methods, all by financing goods, capacity-building and Training on statistical modernization.

2.2. Institutional Reforms for Selected National Statistical Systems.

Supporting: (a) technical assistance to selected Participating Countries to establish mechanisms for sustainable funding of the NSS; (b) updating the legal data protection framework for national statistics to align with international good practice relating to statistical disclosure controls and data protection rules and practices for statistical data; and (c) strengthen statistical coordination and quality assurance, including through elaboration of NSDSs.

2.3. Enhance Human Capital

Strengthen specialization of NSOs' workforce by: (a) providing Training for statisticians including continuous education and on-the-job training to NSO staff; (b) providing scholarships for students admitted to regional and national statistical schools; and (c) supporting regional and national statistical schools to harness innovative technologies to improve capacity and teaching quality of NSO staff and students in the use of modern tools, through provision of goods, small works (only for ENSAE), services, Training and hiring of teaching staff.

2.4. Data Accessibility and Dissemination

Build capacity and provide technical assistance to improve data accessibility and dissemination through: (a) implementation of open data system for archiving and distributing long time data series; (b) establishment and improvement of mechanisms for accessing and sharing microdata and online query, and disseminating statistical findings; and (c) improving the application of IMF data dissemination standards.

2.5. Data Use and Analysis to Inform Public Policy

Support: (a) establishment of tools and provision of skills to inform policy decisions and evaluate the impact of keys actions proposed in the applicable NDP; (b) monitoring and evaluation of the NDP; (c) strengthening of NSOs to provide data literacy campaigns and train key data users; and (d) strengthen macroeconomic forecasting and analysis capacity.

Part 3. Construction, Upgrading and Modernization of Physical Infrastructure.

- 3.1. Construction and Infrastructure Upgrading of selected NSOs and National statistical schools. Support the modernization of selected physical infrastructure through: (a) construction of new buildings; (b) rehabilitation of existing office complexes with modern facilities; and (c) provision of office furniture and equipment.
- 3.2. Modernization of Information and Communications Technology (ICT) and Statistical Infrastructure of NSOs and National Statistical Schools. Support the modernization of NSOs' and regional and national statistical schools' ICT systems, improving access to and use of innovative tools and practices.

Part 4. Project Management, Monitoring, and Evaluation

- **4.1. Project Management.** Support Project management and implementation, including on financial management, procurement, environmental and social aspects, communication, planning, audits, support to the relevant Project management and coordination in each Participating Country and Regional Body, monitoring and evaluation, and Operating Costs.
- **4.2. Project Results and User Satisfaction Monitoring.** Support the costs of Project monitoring and evaluation through data collection and reporting, as well as distribution of user satisfaction survey.

SCHEDULE 2

Project Execution

Section I. Implementation Arrangements

A. Institutional Arrangements

- 1. Project Implementation Unit
 - Subject to paragraph (c) below, the Recipient shall, and shall cause the (a) PIE, to maintain at all times during the implementation of the Project, the Project Implementation Unit (PIU) under the supervision of the director general of the PIE with terms of reference, staff, resources and representation satisfactory to the Association as they shall be further set out in the Project Operations Manual, including inter alia: (i) a Project coordinator; (ii) a procurement specialist; (iii) a financial management specialist; (iv) a communication specialist; (v) an administrative assistant; (vi) a monitoring and evaluation specialist; (vii) environmental, social and gender-based violence staff in accordance with the ESCP; and (viii) any other staff needed to assist in the Project implementation and coordination as further specified in the Project Operations Manual. The PIU shall be responsible for: (i) the day-to-day management and implementation of the Project; (ii) the preparation, adjustments and implementation of the Project management tools, including inter alia, and procurement plans; (iii) coordinating fiduciary, technical, environmental and social aspects; (iv) the preparation of a consolidated report on the implementation of the Project components as well as monitoring and evaluation; and (v) the coordination with the relevant units/departments in other line Ministries to monitor and supervise the activities implemented with the other sectoral Ministries.
 - (b) The Recipient shall, and shall cause the PIE to, designate at all times during Project implementation a representative to participate in the Regional Project Coordination Committee, under terms of reference and with qualified and experienced members in adequate number, all satisfactory to the Association and as further set out in the Project Operations Manual.
 - (c) Notwithstanding and for the purposes of paragraph (a) above and the requirements of the ESCP, the Recipient shall, and shall cause the PIE to: (i) no later than three (3) months after the Effective Date: (A) recruit and thereafter maintain throughout Project implementation an internal auditor and an accountant for the PIU, all with qualifications, experience and terms of reference satisfactory to the Association; and (B) set up a multi-

project computerized accounting system to fit the Project needs with specifications acceptable to the Association; all in a manner and substance satisfactory to the Association; and (ii) no later than six (6) months after the Effective Date, recruit an external auditor, with qualifications, experience and terms of reference satisfactory to the Association.

2. National Steering Committee

The Recipient shall, and shall cause the PIE to, establish and maintain throughout Project implementation, the National Steering Committee, under terms of reference and with qualified and experienced members in adequate number, all satisfactory to the Association and further set out in the Project Operations Manual, which shall be vested with the responsibility to provide oversight of and guidance to the Project Implementation Unit during Project implementation including by ensuring proper coordination of activities in accordance with the Project objectives and approving Annual Work Plan and Budget.

3. Technical Committees

The Recipient shall, and shall cause the PIE to, establish and maintain throughout Project implementation, the Technical Committees, under terms of reference, in a number and with qualified and experienced members in adequate number, all satisfactory to the Association, which shall provide technical support to the Project Implementation Unit with respect to technical activities such as the population and housing census and the household surveys, as further described in the Project Operations Manual.

B. Subsidiary Agreement

- 1. To facilitate the carrying out of Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2, 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2, 2.3, 2.4, 2.5(a), (c) and (d), 3.1(a) and (c), 3.2, 4.1, 4.2 of the Project, the Recipient shall make the proceeds of the Financing available to the PIE under a subsidiary agreement between the Recipient and the PIE ("Subsidiary Agreement") under terms and conditions approved by the Association, which shall include the following:
 - (a) the proceeds of the Financing made available under the Subsidiary Agreement shall be provided to the PIE in the form of budgetary allocations; and
 - (b) the proceeds of the Financing so made available shall be provided on a non-refundable basis.

- 2. The Subsidiary Agreement shall include *inter alia*:
 - the obligation of the PIE to carry out Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2, 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2, 2.3, 2.4, 2.5(a), (c) and (d), 3.1(a) and (c), 3.2, 4.1, 4.2 of the Project with due diligence and efficiency, in conformity with appropriate administrative, financial and technical practices, the Project Operations Manual, Procurement Regulations, Anti-Corruption Guidelines, and Environmental and Social Commitment Plan, and provide, or cause to be provided, promptly as needed, the facilities, services and other resources required for the Project;
 - (b) the right of the Recipient to exercise its rights under the Subsidiary Agreement in such manner as to protect the interests of the Recipient and the Association and to accomplish the purpose of the Financing, including the right of the Recipient, as applicable, to suspend or terminate the PIE's ability to benefit from the proceeds of the Financing;
 - (c) the obligation of the PIE to: (i) comply with record keeping, auditing and reporting requirements set forth in this Agreement (operations, resources and expenditure) for the Project; (ii) at the Association's or the Recipient's request, have such financial statements audited by independent auditors acceptable to the Association, in accordance with consistently applied auditing standards acceptable to the Association; and (iii) promptly furnish the statements as so audited to the Recipient and the Association;
 - (d) the obligation of the PIE to: (i) at the request of the Recipient or the Association, exchange views with the Recipient and the Association with regard to the progress of the Project and the performance of its obligations under the Subsidiary Agreement; (ii) enable the Recipient and the Association to inspect the PIE's implementation of activities under the Project and any relevant records and documents; and (iii) prepare and furnish to the Recipient and the Association all such information as the Recipient or the Association shall reasonably request; and
 - (e) the obligation of the PIE to promptly inform the Recipient and the Association of any condition which interferes or threatens to interfere with the progress of the Project, or the performance of its obligations under the Subsidiary Agreement.
- 3. The Recipient shall exercise its rights under the Subsidiary Agreement in such manner as to protect the interests of the Recipient and the Association and to accomplish the purposes of the Financing. Except as the Association shall otherwise agree, the Recipient shall not assign, amend, abrogate or waive the Subsidiary Agreement or any of its provisions.

4. In the event of any conflict between the provisions of the Subsidiary Agreement and the provisions of this Agreement, the provisions of this Agreement shall prevail.

C. Project Operations Manual

- 1. The Recipient, through the PIE, shall carry out Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2, 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2, 2.3, 2.4, 2.5(a), (c) and (d), 3.1(a) and (c), 3.2, 4.1, 4.2 of the Project in accordance with the arrangements, procedures and guidelines set out in the Project Operations Manual (POM), containing detailed arrangements and procedures, satisfactory to the Association, for: (a) institutional coordination and day-to-day execution of the Project; (b) Project budgeting, disbursement and financial management; (c) procurement; (d) monitoring, evaluation, reporting and communication; (e) environmental and social standards management; (f) the modalities for handling Personal Data in accordance with applicable national law and good international practice; (g) the eligibility criteria and procedures for the provision of scholarships under Part 2.3(b) of the Project; (h) rules and procedures for the procurement and/or use, operation and maintenance of drones during Project implementation, including appropriate risk mitigation plans; and (i) such other administrative, financial, technical and organizational arrangements and procedures as shall be required for the Project.
- 2. The Recipient, through the PIE, shall:
 - (a) take all action required to carry out Parts 1.2.1, 1.2.2, 1.2.3, 1.3.1, 1.3.2, 1.3.3, 1.4.1, 1.4.2, 1.5.1, 1.5.2, 2.1, 2.2, 2.3, 2.4, 2.5(a), (c) and (d), 3.1(a) and (c), 3.2, 4.1, 4.2 of the Project in accordance with the provisions and requirements set forth or referred to in the Project Operations Manual;
 - (b) submit recommendations to the Association for its consideration for changes and updates of the Project Operations Manual as they may become necessary or advisable during Project implementation in order to achieve the objectives of the Project; and
 - (c) not assign, amend, abrogate or waive the Project Operations Manual or any of its provisions without the prior approval of the Association. Notwithstanding the foregoing, if any of the provisions of the Project Operations Manual is inconsistent with the provisions of this Agreement, the provisions of this Agreement shall prevail and govern.

D. Annual Work Plan and Budget (AWP&B)

1. The Recipient shall, through the PIE, prepare and furnish to the Association not later than November 30 of each year during the implementation of the Project (or for the first calendar year of Project implementation, no later than one (1) month

after the Effective Date), a draft work plan and budget for Project implementation, setting out, *inter alia:* (a) a detailed description of all activities proposed to be included in the Project for the subsequent year; (b) a proposed financing plan for expenditures required for such activities, including proposed amounts and sources of financing; (c) environmental and social instruments applicable to such activities in accordance with the provisions of ESCP; and (d) responsibility for execution of said Project activities, budgets, start and completion dates, outputs and monitoring indicators to track progress of each activity.

- 2. Each such proposed work plan and budget shall specify any Training activities that may be required under the Project, including: (a) the type of Training; (b) the purpose of the Training; (c) the personnel to be trained; (d) the institution or individual who will conduct the Training; (e) the location and duration of the Training; and (f) the cost of the Training.
- 3. The Recipient shall, through the PIE, afford the Association a reasonable opportunity to exchange views with the Recipient on each such proposed work plan and budget, before adoption of the final version of said plan and budget no later than December 31 of each year by the National Steering Committee in the form satisfactory to the Association, and thereafter, ensure that the Project is implemented with due diligence during said subsequent year in accordance with such work plan and budget as shall have been approved by the Association ("Annual Work Plan and Budget" or "AWP&B").
- 4. The Recipient or the PIE shall not make or allow to be made any change(s) to the approved AWP&B without prior approval in writing by the Association.

E. Environmental and Social Standards

- 1. The Recipient shall, and shall cause the PIE to, ensure that the Project is carried out in accordance with the Environmental and Social Standards, in a manner acceptable to the Association.
- 2. Without limitation upon paragraph 1 above, the Recipient shall, and shall cause the PIE to, ensure that the Project is implemented in accordance with the Environmental and Social Commitment Plan ("ESCP"), in a manner acceptable to the Association. To this end, the Recipient shall, and shall cause the PIE to, ensure that:
 - (a) the measures and actions specified in the ESCP are implemented with due diligence and efficiency, as provided in the ESCP;
 - (b) sufficient funds are available to cover the costs of implementing the ESCP;

- (c) policies and procedures are maintained, and qualified and experienced staff in adequate numbers are retained to implement the ESCP, as provided in the ESCP; and
- (d) the ESCP, or any provision thereof, is not amended, repealed, suspended or waived, except as the Association shall otherwise agree in writing, as specified in the ESCP, and ensure that the revised ESCP is disclosed promptly thereafter.
- 3. Without limitation upon the provisions of paragraph 2 above, if sixty (60) days prior to the Closing Date, the Association determines that there are measures and actions specified in the ESCP which will not be completed by the Closing Date, the Recipient shall, and shall cause the PIE to: (a) not later than thirty (30) days before the Closing Date, prepare and present to the Association, an action plan satisfactory to the Association on the outstanding measures and actions, including a timetable and budget allocation for such measures and actions (which action plan shall deemed to be considered an amendment of the ESCP); and (b) thereafter, carry out said action plan in accordance with its terms and in a manner acceptable to the Association.
- 4. In case of any inconsistencies between the ESCP and the provisions of this Agreement, the provisions of this Agreement shall prevail.
- 5. The Recipient shall, and shall cause the PIE to, ensure that:
 - (a) all measures necessary are taken to collect, compile, and furnish to the Association through regular reports, with the frequency specified in the ESCP, and promptly in a separate report or reports, if so requested by the Association, information on the status of compliance with the ESCP and the environmental and social instruments referred to therein, all such reports in form and substance acceptable to the Association, setting out, *inter alia*: (i) the status of implementation of the ESCP; (ii) conditions, if any, which interfere or threaten to interfere with the implementation of the ESCP; and (iii) corrective and preventive measures taken or required to be taken to address such conditions; and
 - (b) the Association is promptly notified of any incident or accident related to or having an impact on the Project which has, or is likely to have, a significant adverse effect on the environment, the affected communities, the public or workers in accordance with the ESCP, the environmental and social instruments referenced therein and the Environmental and Social Standards.
- 6. The Recipient shall, and shall cause the PIE to, establish, publicize, maintain and operate an accessible grievance mechanism, to receive and facilitate resolution of

concerns and grievances of Project-affected people, and take all measures necessary and appropriate to resolve, or facilitate the resolution of, such concerns and grievances, in a manner acceptable to the Association.

7. The Recipient shall, and shall cause the PIE to, ensure that all bidding documents and contracts for civil works under the Project include the obligation of contractors, subcontractors and supervising entities to: (a) comply with the relevant aspects of the ESCP and the environmental and social instruments referred to therein; and (b) adopt and enforce codes of conduct that should be provided to and signed by all workers, detailing measures to address environmental, social, health and safety risks, and the risks of sexual exploitation and abuse, sexual harassment and violence against children, all as applicable to such civil works commissioned or carried out pursuant to said contracts.

F. Data Protection

Prior to the carrying out of any Personal Data collection and processing activities under the Project, the Recipient shall, and shall cause the PIE to, ensure that its staff and any third party contracted for the purpose, follow adequate data protection standards and protocols, in accordance with applicable national law and good international practice and acceptable to the Association, as such standards and protocols shall be incorporated in the Project Operations Manual and, where appropriate, the applicable terms of reference.

G. Memoranda of Understanding with ECOWAS

- 1. In order to maximize the benefits of regional harmonization for purposes of the Project, the Recipient shall enter into a separate memorandum of understanding with ECOWAS (the "Mauritania MOU"), in form and substance satisfactory to the Association, as such Mauritania MOU shall include provisions to the effect of ensuring that the Recipient shall participate in any activity carried out by ECOWAS under the Project, including *inter alia* training events, workshops, data collection and analysis or knowledge-sharing.
- 2. The Recipient shall exercise its rights and obligations under the Mauritania MOU in such manner as to protect the interests of the Recipient and the Association and to accomplish the purposes of the Financing. Except as the Association shall otherwise agree, the Recipient shall not assign, amend, abrogate or waive the Mauritania MOU or any provision contained therein (whether in whole or in part).
- 3. In the event of any conflict between the provisions of the Mauritania MOU and those of this Agreement the provisions of this Agreement shall prevail.

H. Procurement and/or Use of Drones in Project Implementation

- 1. Prior to procurement and/or use of drones under the Project, the Recipient shall:
 - (a) notify the Association of such proposed procurement and/or use, and afford the Association a reasonable opportunity to assess any risks related to such procurement and/or use, including operational, legal and regulatory, institutional, technical, social and environmental, and fiduciary risks, and to recommend appropriate mitigation measures; and
 - (b) develop a risk mitigation plan for the procurement and/or use of drones, in form and substance acceptable to the Association.
- 2. The Recipient shall ensure that no drones shall be procured and/or used under the Project unless the Recipient has implemented the risk mitigation measures in accordance with paragraph 1 above, the Project Operations Manual, and the ESCP, in form and manner satisfactory to the Association.
- 3. No drones procured under the Project shall be used for any purpose other than those set out in Part 1.4.1 of the Project and for which the risk mitigation plan referred to in paragraph 1(b) above has been developed and implemented, except where the Association has provided its prior approval in writing for such use based on: (a) assessment of the risks involved; and (b) implementation of appropriate risk mitigation measures.

Section II. Project Monitoring, Reporting and Evaluation

The Recipient shall, and shall cause the PIE to, furnish to the Association each Project Report not later than one (1) month after the end of each calendar semester, covering the calendar semester. Except as may otherwise be explicitly required or permitted under this Agreement or as may be explicitly requested by the Association, in sharing any information, report or document related to the activities described in Schedule 1 of this Agreement, the Recipient shall, and shall cause the PIE to, ensure that such information, report or document does not include Personal Data.

Section III. Withdrawal of the Proceeds of the Financing

A. General

Without limitation upon the provisions of Article II of the General Conditions and in accordance with the Disbursement and Financial Information Letter, the Recipient may withdraw the proceeds of the Financing to: (a) finance Eligible Expenditures; and (b) repay the Preparation Advance; in the amount allocated and, if applicable, up to the percentage set forth against each Category of the following table:

- 4. "Category" means a category set forth in the table in Section III.A of Schedule 2 to this Agreement.
- 5. "CPI" means consumer price index.
- 6. "ECOWAS" means the Economic Community of West African States, established and operating pursuant to the ECOWAS Revised Treaty.
- 7. "ECOWAS Revised Treaty" means the establishment treaty of ECOWAS, signed in Cotonou, Benin, on July 24, 1993.

- 9. - 10. - 15. "National Steering Committee" means the steering committee to be established in accordance with Section I.A.2 of Schedule 2 to this Agreement.
- 16. - 18. "NSS" means the national statistical system of each of the Participating Countries.
- 19. "NDP" means the national development plan of each Participating Country.
- 20. "Operating Costs" means the reasonable incremental expenses incurred by the Recipient in connection with Project implementation, including consumable materials and supplies, communications, mass media and printing services, vehicle purchase, insurance, rental, operation and maintenance, utilities, office rental and maintenance, charges for the opening and operation of bank accounts required for the Project, travel, lodging and *per diems*, and salaries of staff working on the Project (other than consulting services), but excluding salaries of officials of the Recipient and the PIE.
- 21. "Participating Countries" means the countries participating in this regional Project, namely Benin, The Gambia, Guinea, Guinea-Bissau, Mauritania, Niger, Mali and Senegal. "Participating Country" means any one of the Participating Countries.
- 22. "Personal Data" means any information relating to an identified or identifiable individual. An identifiable individual is one who can be identified by reasonable means, directly or indirectly, by reference to an attribute or combination of attributes within the data, or combination of the data with other available information. Attributes that can be used to identify an identifiable individual include, but are not limited to, name, identification, number, location data, online identifier, metadata and factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of an individual.
- 23. "Preparation Advance" means the advance referred to in Section 2.07(a) of the General Conditions, granted by the Association to the Recipient pursuant to the letter agreement No. V4760 signed on behalf of the Association and on behalf of the Recipient on March 22, 2023.

- 24. "Procurement Regulations" means, for purposes of paragraph 85 of the Appendix to the General Conditions, the "World Bank Procurement Regulations for IPF Borrowers", dated November 2020.
- 25. "Project Implementation Unit" or "PIU" means the implementation unit for the Project referred to in Section I.A.1 of Schedule 2 to this Agreement.
- 26. "Project Implementing Entity" or "PIE" means Agence Nationale de la Statistique et de l'Analyse Démographique et Economique (ANSADE), a public autonomous legal entity established pursuant to Décret No. 2021-027/PM/MAEPSP/MF portant création, organisation et fonctionnement d'un établissement public à caractère administratif dénommé : Agence Nationale de la Statistique et de l'analyse Démographique et Economique (ANSADE) dated February 25, 2021.
- 27. "Project Operations Manual" or "POM" means the Project's implementation manual referred to in Section I.C of Schedule 2 to this Agreement.
- 28. "Regional Bodies" means the regional and sub-regional organizations participating in this regional Project, namely the African Union, the ECOWAS and the WAEMU.
- 29. "Regional Project Coordination Committee" or "RPCC" means the committee to be established by ECOWAS that shall (A) be responsible for coordination of Project implementation among the Participating Countries and the Regional Bodies including, *inter alia*: (a) developing, coordinating and following up on implementation of statistical harmonization activities, and (b) monitoring and evaluation of Project implementation, as further described in the Project Operations Manual; (B) meet at least once a year; and (C) include representatives of all Participating Countries and Regional Bodies, as well as representatives of the Association and other entities as further described in the Project Operations Manual.
- 30. "Regional Statistical Program 2023-2027" means the regional program of statistical development activities validated on December 16, 2022, by ECOWAS member states' expert statisticians for the period 2023-2027, aiming at developing a harmonized and coordinated regional statistical system.
- 31. "SHaSA2" means the second Strategy for the Harmonization of Statistics in Africa of January 2018.
- 32. "Signature Date" means the later of the two dates on which the Recipient and the Association signed this Agreement and such definition applies to all references to "the date of the Financing Agreement" in the General Conditions.

- 33. "STATAFRIC" means the African Union Institute for Statistics, a specialized technical office of the African Union Commission, established pursuant to decision Assembly/AU/462 (XX) of January 27-28, 2013.
- 34. "Subsidiary Agreement" means the agreement referred to in Section I.B of Schedule 2 to this Agreement pursuant to which the Recipient shall make part of the proceeds of the Financing available to the Project Implementing Entity.
- 35. "Technical Committees" means the committees to be established in accordance with Section I.A.3 of Schedule 2 to this Agreement.
- 36. "Training" means the costs incurred for purposes of training under the Project, including through seminars, workshops, knowledge sharing activities and study tours, tuition and scholarships, and covers the following costs associated with such activity: travel and subsistence costs for training participants, costs associated with securing the services of trainers, rental of training facilities, preparation and reproduction of training materials, and other costs directly related to training preparation and implementation.
- 37. "Umbrella Environmental and Social Management Framework" or "U-ESMF" means the umbrella environmental and social management framework for the Project, as the same may be amended from time to time in accordance with the provisions thereof, which the Recipient shall prepare, disclose, consult upon and adopt in accordance with the ESCP and in form and substance satisfactory to the Association.
- 38. "Umbrella Labor Management Procedures Framework" or "U-LMPF" means the umbrella labor management procedures framework for the Project, as the same may be amended from time to time in accordance with the provisions thereof, which the Recipient shall prepare, disclose, consult upon and adopt in accordance with the ESCP and in form and substance satisfactory to the Association.
- 39. "West African Economic and Monetary Union" or "WAEMU" means l'Union Economique et Monétaire Ouest Africaine (UEMOA) established and operating pursuant to a treaty signed in Dakar on January 10, 1994, as amended in 2003 (the Modified WAEMU Treaty).
