

# BLEARNING POVERTY: A WORLD BANK-UIS INDICA-ÖTOR TO HIGHLIGHT THE LEARNING CRISIS

agateway for learning as the child progresses through school and conversely, an inability to read constrains opportunities for further learning. Reading proficiency is also critical for foundational learning in other subjects.

In low- and middle-income countries, more than half the children cannot read and understand a simple story by the end of primary school. This learning crisis threatens countries' efforts to build human capital and achieve the Sustainable Development Goals (SDGs), undermining sustainable growth and poverty reduction.

Tackling the learning crisis in the foreseeable future requires rapid progress at a scale that has not been seen yet. To galvanize action on this crisis, we introduced the concept of Learning Poverty (LP), a measure constructed jointly by the World Bank and the UNESCO Institute for Statistics (UIS).

#### WHAT IS LEARNING POVERTY?

Learning Poverty means being unable to read and understand A short, age-appropriate text by age 10. All foundational skills Fare important, but we focus on reading because: (i) read-Eng proficiency is an easily understood measure of learning; *∃*ii) reading is a student's gateway to learning in every other garea; and, (iii) reading proficiency can serve as a proxy for Foundational learning in other subjects.

Great the Learning Poverty indicator allows us to illustrate progress toward SDG 4's broader goal to ensure inclusive gand equitable quality education for all. It particularly high**a** gights progress towards **SDG 4.1.1b**, which specifies that all achildren at the end of primary reach at least a minimum proficiency level (MPL) in reading.

#### HOW IS LEARNING POVERTY MEASURED?

The indicator combines the share of primary-aged children out-of-school who are Schooling Deprived (SD), and the share of pupils below a minimum proficiency in reading, who are Learning Deprived (LD). By combining schooling and learning, the indicator brings into focus both "more schooling", which by itself serves a variety of critical functions, as well as "better learning," which is important to ensure that time spent in school translates into acquisition of skills and capabilities.

$$LP = SD + [(1 - SD) \times LD]$$

where, LP is Learning Poverty; LD, Learning Deprivation, is share of children at the end of primary below minimum proficiency, as defined by the Global Alliance to Monitor Learning (GAML) in the context of the SDG 4.1.1b monitoring; SD, Schooling Deprivation, is the share of primary-aged children who are out-of-school, and is linked to SDG 4.1.4. All out-of-school children are implicitly assumed to be below minimum proficiency.

The data used to calculate Learning Poverty has been made possible thanks to the work of the Global Alliance to Monitor Learning led by UIS, which established minimum proficiency levels that enable countries to benchmark learning across different cross-national and national assessments.

#### LEARNING POVERTY IN YEMEN, REP

- Learning Poverty. 95 percent of children in Yemen, Rep at late primary age today are not proficient in reading, adjusted for the out-of-school children.
- Learning Deprivation. Large-scale learning assessments of students in Yemen, Rep indicate that 94 percent do not achieve the MPL at the end of primary school, proxied by data from grade 4 in 2011.
- Schooling Deprivation. In Yemen, Rep, 18 percent of primary school-aged children are not enrolled in school. These children are excluded from learning in school.


For countries with very low Schooling Deprivation, the share of children with Learning Deprivation will be very close to the reported Learning Poverty.

Notes: The LP number for Yemen, Rep is calculated using the Global Learning Assessment Database (GLAD) harmonization based on TIMSS and the MPL threshold used was level Low (400 points). For more details, please consult the GLAD and Learning Poverty repositories in GitHub.

#### **BENCHMARKING YEMEN, REP'S LEARNING POVERTY**

Learning Poverty in Yemen, Rep is 36.8 percentage points higher than the average for the Middle East and North Africa region and 4.7 percentage points higher than the average for low income countries.

# HOW DOES YEMEN, REP'S GENDER GAP COMPARE GLOBALLY?

As in most countries, **Learning Poverty is higher for boys than for girls** in Yemen, Rep.

This result is a composition of two effects. First, the share of **out-of-school children is lower for boys** (10%) than for girls (26%).

Second, **boys are less likely to achieve minimum proficiency** at the end of primary school (94.2%) than girls (92.5%) in Yemen, Rep.



## PRIMARY EDUCATION EXPENDITURE

Primary education expenditure per child of primary education age in Yemen, Rep is USD 737 (PPP), which is 82.9% below the average for the Middle East and North Africa region and 310.9% above the average for low income countries.

#### DATA AND DATA GAPS ON LEARNING AND SCHOOL-ING IN YEMEN, REP


Yemen, Rep does not administer a National Large-Scale Assessment (NLSA) at the end of primary school, according to UIS SDG 4.1.1b monitoring.

Yemen, Rep participated in the following published crossnational learning assessments in recent years: TIMSS (2003, 2007, 2011).

According to the World Bank's 2013 LeAP diagnostic analysis of Yemen, Rep's assessment system, the country's ratings on large-scale assessment activities were **Emerging (2 out of 4)** on Cross-National Learning Assessment and **Latent (1 out of 4)** on NLSA. **Latent** is absence of, or deviation from, attribute. **Emerging** is partial presence of attribute. **Established** is acceptable minimum standard on indicator. **Advanced** is ideal or current best practice. To update results, contact LeAP team.

The out-of-school adjustment in Learning Poverty relies on enrollment data. Our preferred definition is the adjusted net primary enrollment rate (ANER) as reported by UIS. This data relies both on the population census and EMIS (Education Management Information System). We use enrollment data for the year closest to the assessment year. In the case of Yemen, Rep, ANER based on EMIS data is for 2011.
