


*Amendment No. 1 to the Administration Agreement between the Norwegian Ministry of Foreign Affairs and the International Bank for Reconstruction and Development and the International Development Association concerning the Multi-Donor Trust Fund for Co-financing of the Ukraine Second Economic Recovery Development Policy Program (Trust Fund No. 073792; Donor Reference No. UKR-22/0003)*

1. Reference is made to the Administration Agreement between the Norwegian Ministry of Foreign Affairs (the "Donor") and the International Bank for Reconstruction and Development and the International Development Association (collectively, the "Bank" and together with the Donor, the "Parties" and each a "Party") concerning the Multi-Donor Trust Fund for Co-financing of the Ukraine Second Economic Recovery Development Policy Program (Trust Fund No. 073792) (the "Trust Fund") effective as of April 11, 2022 (the "Administration Agreement").
2. The Bank acknowledges that the Donor agrees, subject to legislative appropriations, to provide the sum of one hundred million Norwegian Kroner (NOK 100,000,000) (the "Contribution") for the Trust Fund in accordance with the terms of the Administration Agreement.
3. The Donor shall deposit the Contribution in the currency specified in paragraph 2 above into such bank account designated by the Bank promptly following countersignature of this amendment (the "Amendment") and submission of a payment request by the Bank.
4. When making a deposit, the Donor shall instruct its bank to include in its deposit details information (remittance advice) field of its SWIFT deposit message, information indicating: the amount deposited, that the deposit is made by the Donor for Trust Fund No. 073792 (the Multi-Donor Trust Fund for Co-financing of the Ukraine Second Economic Recovery Development Policy Program), and the date of the deposit (the "Deposit Instructions"). In addition, the Donor shall provide a copy of the Deposit Instructions to the Bank's Accounting Trust Funds Division by e-mail sent to [tfremittadvice@worldbank.org](mailto:tfremittadvice@worldbank.org) or by fax sent to +1 (202) 614-1315.
5. All other terms of the Administration Agreement shall remain the same.

The Parties are requested to sign and date this Amendment, and upon possession by the Bank of this fully signed Amendment, this Amendment shall come into effect as of the date of the last signature.
