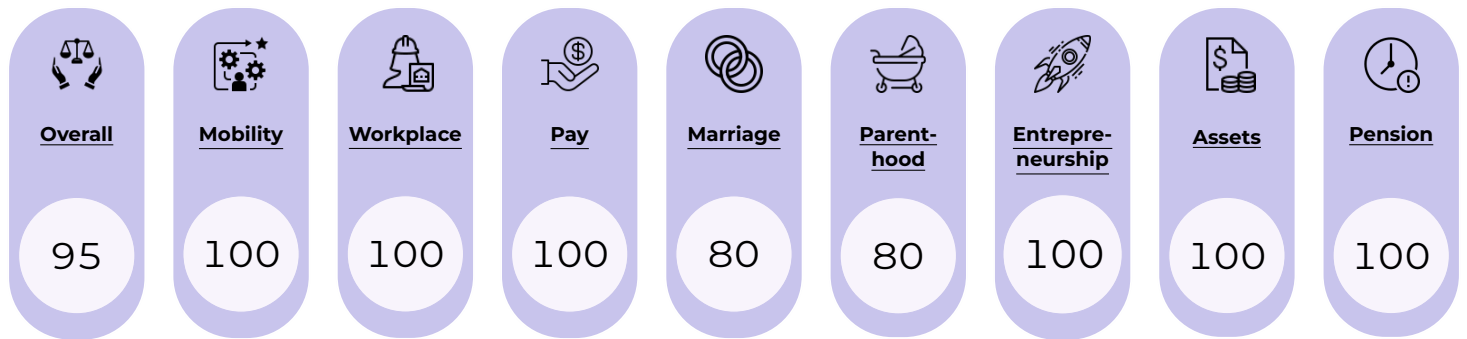

Peer Comparison shows how Cote d'Ivoire performs relative to its peers in the region, income group, and the world. Color coding represents values 10 percent above or below its peers in the region.

Women, Business and the Law in Cote d'Ivoire

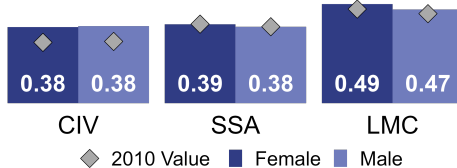
Women, Business and the Law (WBL) 2022 presents an index covering 190 economies, structured around the life cycle of a working woman. In total, 35 questions are scored across eight indicators. **Cote d'Ivoire scores 95 out of 100**, while the regional average across Sub-Saharan Africa is 73.



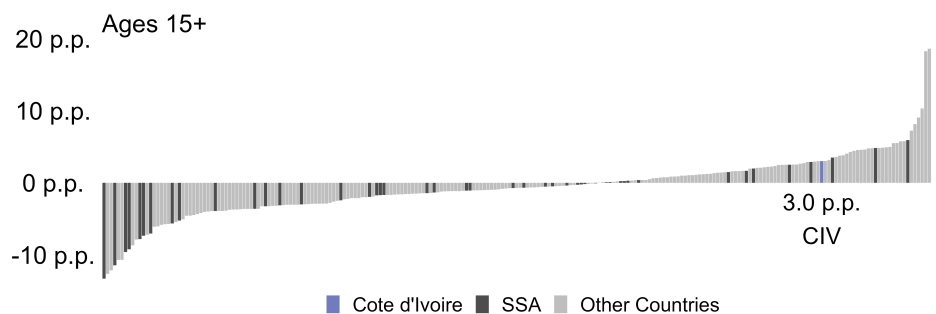
A Closer Look at Gender Equality in Cote d'Ivoire

Despite some progress, gender gaps, gender-based violence, and disadvantageous social norms facing women and girls persist, and gains in human capital of women and girls remain untapped. Turning human capital investments into economic gains means addressing multiple barriers to women's economic empowerment, including improving their voice and agency.
