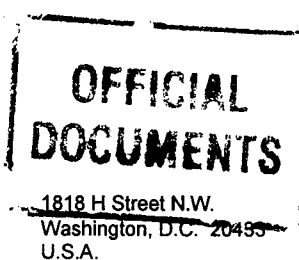

***Supplemental Contribution to the Administration Agreement between the Government of the Republic of Finland and the International Bank for Reconstruction and Development and the International Development Association concerning the Trust Fund for Environmentally and Socially Sustainable Development (TF050887)***

Dear Mr. Julin:


1. We refer to the Administration Agreement between the Government of Republic of Finland (the "Donor") and the International Bank for Reconstruction and Development ("IBRD") and the International Development Association ("IDA"), (collectively, the "Bank") regarding the Trust Fund for Environmentally and Socially Sustainable Development ("TFESSD") (TF050887) (the "Trust Fund") effective as of November 25, 2002, as amended (the "Administration Agreement").
2. We are pleased to acknowledge, on behalf of the Bank, the intention of the Donor to make a supplemental contribution to the Trust Fund in the amount of one million five hundred thousand Euros (EUR 1,500,000) (the "Supplemental Contribution").
3. Any payment to be made under this Amendment is subject to there being an annual approval by the Parliament of Finland for the fiscal year in which the payment is to be made.
4. The Donor shall deposit the Supplemental Contribution into such bank account designated by the Bank promptly following countersignature of this Amendment by the Donor and submission of a payment request by the Bank.
5. When making such deposit, the Donor shall instruct its bank to include in its payment details information (remittance advice) field of its SWIFT payment message, information indicating: the amount paid, that the payment is made by the Donor for the TF050887 (Trust Fund for Environmentally and Socially Sustainable Development), and the date of the deposit. In addition the Donor shall provide a copy of the deposit

instruction to the Bank's Accounting Trust Funds Division by e-mail sent to [tfremiadvice@worldbank.org](mailto:tfremiadvice@worldbank.org) or by fax sent to (202) 614-1315.

6. Immediately upon receipt of the Supplemental Contribution funds, the Bank will convert such funds into United States dollars.
7. All other terms of the Administration Agreement shall remain the same.
8. The Bank will disclose this Amendment and related information on this Trust Fund in accordance with the World Bank Policy on Access to Information. By entering into this Amendment, the Donor consents to disclosure of this Amendment and related information on this Trust Fund.
9. We propose that this letter shall constitute an amendment to the Administration Agreement between the Bank and the Donor. Please confirm your acceptance to the foregoing, on behalf of the Donor, by signing and dating the two originals, retaining one original for your records and returning the other original to the Bank. Upon receipt by the Bank of the original Amendment countersigned by you, this Amendment will become effective as of the date of the countersignature.




