Amendment to the Grant Agreement***

We refer to the Grant Agreement dated October 15, 2006, between People's Republic of Bangladesh (the Recipient) and the International Development Association (the Association) acting as Administrator (the Administrator) of grant funds provided by a group of Donors for the Health, Nutrition and Population Sector Program (HNPSP), as previously amended and the Ministry of Health and Family Welfare (MOHFW)'s letter sent by Ms. Nargis Khanam, Senior Assistant Secretary, Planning Wing (MOHFW) dated January 25, 2011, requesting the Association to reallocate available funds between categories in order to ensure that unspent funds are used for high priority program activities.

The Association concurs with your request and the Grant Agreement is amended as follows:-

1. Section 2.01 is amended as follows:  
The amount of the Grant in Section 2.01 of the Grant Agreement has been increased from USD 335,000,000 to USD 387,983,352.
2. Schedule 1 "Withdrawals of the Multi-donor Trust Fund Grant" is hereby amended to read as shown in Annex 1 to this Amendment.

## Withdrawal of the Multi-Donor Trust Fund Grant

The table below sets forth the Categories of items to be financed out of the proceeds of the total Contribution of all Donors contributing to this Trust Fund and the approximate share percentage of the total Contribution for each Category:

(1) Goods, works, services, and Operating Costs under Part D of the Project	11%
(2) Services of NGO and other private and non-public providers	14%
(3) Goods (other than those covered by Category 1)	65%
(4) Works (other than those covered by Category 1)	3%
