GUARANTEE AGREEMENT

Without limitation or restriction upon any of its other obligations under the Guarantee Agreement, the Guarantor hereby unconditionally guarantees, as primary obligor and not as surety merely, the due and punctual payment of all Loan Payments payable by TSKB pursuant to the TSKB Loan Agreement.
