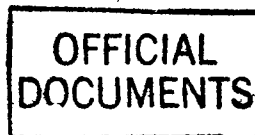

Amendment to the Administration Agreement between the Government of the Swiss Confederation, represented by the Federal Department of Foreign Affairs, acting through the Swiss Agency for Development and Cooperation, and the International Development Association concerning the Bangladesh Climate Change Resilience Fund for the Climate Change Program in the People's Republic of Bangladesh (TF No. TF071208)

Dear Ambassador Herren:

1. We refer to the Administration Agreement between the Government of the Swiss Confederation, represented by the Federal Department of Foreign Affairs, acting through the Swiss Agency for Development and Cooperation (the "Donor") and the International Development Association (IDA) regarding the Bangladesh Climate Change Resilience Fund (BCCRF) for the Climate Change Program in the People's Republic of Bangladesh (TF071208) (the "Trust Fund") effective December 6, 2010 (the "Administration Agreement").

2. Pursuant to recent discussions between IDA and the Donor, IDA proposes to amend paragraph 8.1 of Annex 2 to the Administration Agreement to extend the end-disbursement date to June 30, 2017 and to read as follows:


"8.1. It is expected that the Contribution funds will be fully disbursed by IDA in accordance with the provisions of this Agreement by June 30, 2017. IDA shall only disburse Contribution funds for the purposes of this Agreement after such date with the written approval of the Donors."

3. All other terms of the Administration Agreement shall remain the same.

4. IDA will disclose this Agreement and related information on this Trust Fund in accordance with the World Bank Policy on Access to Information. By entering into this Agreement, the Donor consents to disclosure of this Agreement and related information on this Trust Fund.

5. We propose that this letter shall constitute an amendment to the Administration Agreement between IDA and the Donor. Please confirm your acceptance to the foregoing, on behalf of the Donor, by signing and dating the two originals, retaining one original for your records and returning the other original to IDA. Upon receipt by IDA of the original Amendment countersigned by all the current Donors to the Trust Fund, this Amendment will become effective as of the date of the countersignature.
