Implementation Status and Key Decisions

The Madagascar Public Sector Performance Project (PASP) was approved by the Bank's Board of Executive Directors on June 13, 2016; however, it has yet to become effective as Madagascar's Parliament will only convene to vote on the approval of the project in October 2016. In the interim period, a Project Preparation Advance (PPA) has begun to disburse in order to fund preparatory activities—a number of which have already been achieved, including: (i) the adoption of performance contracts in the customs administration (DGD); (ii) the mobilization of stakeholders for the rollout of the unique identifier numbers under the leadership of the Tax Department (DGI); (iii) the launch of a national process to improve the local governance index (IGL) under the leadership of the Ministry of Interior and Decentralization (MID); and (iv) the mobilization of civil society to monitor the project.
