We refer to: (a) the Financing Agreements 4842-LR (Original Financing Agreement) and 5055-LR (Additional Financing Agreement) for the financing of the Liberia Electricity System Enhancement Project, dated December 2, 2010 and March 20, 2012, respectively, between Liberia and the International Development Association (the Association); and (b) the letter from the Republic of Liberia dated February 5, 2015, requesting the extension of the above-referenced Projects.


