***Contribution Agreement between the Global Fund to Fight AIDS,
Tuberculosis and Malaria and the International Bank for Reconstruction
and Development, as Trustee of the Trust Fund for the Global Fund to
Fight AIDS, Tuberculosis and Malaria (MTO No. 069001)***

Dear Dr. Dybul,

We are pleased to acknowledge on behalf of the International Bank for Reconstruction and Development (the IBRD), as Trustee of the Trust Fund, the intention of the Global Fund to Fight AIDS, Tuberculosis and Malaria (the "Donor") to make available to the IBRD, a contribution of up to Thirty Million United States Dollars (USD 30,000,000) (the "Contribution") as a grant for the Trust Fund. The Contribution shall consist of individual contributions received by the Donor from various contributors, including corporations, foundations, charitable organizations and/or individuals.

The Donor understands and agrees that the IBRD shall administer the Contribution in accordance with the terms and conditions of the Amended and Restated Trust Fund Agreement dated as of March 7, 2014 between the Global Fund to Fight AIDS, Tuberculosis and Malaria and the IBRD, as Trustee of the Trust Fund (the "Trust Fund Agreement") and acknowledges that the Donor has received a copy of the Trust Fund Agreement.

The exact amount of the Contribution to be provided to the IBRD will be dependent upon the amount of funding available to the Donor for the purposes of the grant as determined by the Donor in its sole discretion. The Donor shall make payment of the Contribution in installments during the period from the date of this agreement ("Agreement") to and including December 31, 2015.

Each installment shall be deposited into such bank account designated by the IBRD and following a submission of a payment request by the IBRD.

When making such deposit, the Donor shall instruct its bank to include in its payment details information (remittance advice) field of its SWIFT payment message, information indicating: the amount paid, that the payment is made by the Donor for MTO No. 069001 (the Global Fund to Fight AIDS, Tuberculosis and Malaria), and the date of the deposit (the "Deposit Instruction"). In addition, the Donor shall provide a copy of the Donor's Deposit Instruction to the IBRD's Accounting Trust Funds Division by e-mail sent to tfremiadvice@worldbank.org or by fax sent to (202) 522-0739.

Additional contributions by the Donor to the IBRD as a grant for the Trust Fund may be made through amendment of this Agreement to reflect such additional contributions.

In the event that The Global Fund is dissolved and there are funds remaining in the Trust Fund account after the payment of all debts and obligations, the IBRD shall refund to the Donor a proportional share of such funds representing the total of this Contribution compared to all contributions to the Trust Fund.


