The Borrower is a duly existing Public Authority under the laws of the Republic of Turkey with full authority to carry out its present business, to execute and deliver the Loan Assumption Agreement and to carry out the Project in accordance with the terms and conditions thereof, and has fully disclosed to the Bank all facts and circumstances which may materially affect the foregoing.
