Project Implementation Agreement

for the Kiribati Outer Islands Transport Infrastructure Investment Project (KOITIIP)

THIS PROJECT IMPLEMENTATION AGREEMENT	("Agreement") is made on

BY AND BETWEEN:

- (1) ASIAN DEVELOPMENT BANK ("ADB"); and
- (2) INTERNATIONAL BANK FOR RECONSTRUCTION AND DEVELOPMENT ("IBRD")/INTERNATIONAL DEVELOPMENT ASSOCIATION ("IDA") ("IBRD" and "IDA", collectively, the "World Bank")

each a "Cofinancier" and collectively the "Cofinanciers".

RECITALS:

- (A) The Borrower has requested the Cofinanciers to provide financing for the Project, and has entered, or intends to enter, into the Financing Agreements with the Cofinanciers to finance the Project;
- (B) The Borrower has requested that with respect to Project procurement related activities financed or to be financed by the Cofinanciers and except as expressly provided in this Agreement: (a) the Lead Cofinancier's Procurement Framework be used in connection with such activities, and (b) the Lead Cofinancier takes a leading role in providing support and monitoring with respect to the procurement activities under a Project;
- (C) The Cofinanciers agree with the Borrower's request described in paragraph (B) hereinabove and consider that a coordinated and unified approach to procurement would advance the interest of the Project, the Borrower, and the Cofinanciers;
- (D) The Cofinanciers have entered into a procurement framework agreement dated December 3, 2018 under which the Cofinanciers have agreed to a coordinated and unified approach to procurement for jointly financed Projects within the jurisdiction of their common Borrowers, ("Procurement Framework Agreement"); and
- (E) In addition to the Procurement Framework Agreement, the Cofinanciers hereby enter into this Agreement setting out the specific arrangements required for the Project.

IT IS AGREED:

CLAUSE 1

Definitions

- 1.01. Unless otherwise defined below, capitalized terms in this Agreement have the meanings given to them in the Procurement Framework Agreement.
 - (a) "Anticorruption Framework" means (i) with respect to ADB, ADB's Anticorruption Policy (1998, as amended to date) and ADB's Integrity Principles and Guidelines (2015, as amended from time to time); and (ii) with respect to the World Bank, the Guidelines on Preventing and Combating Fraud and Corruption in Projects financed by IBRD loans and IDA Credits and Grants", dated October 15, 2006 and revised in January 2011 and as of July 1, 2016.
 - (b) "Borrower" means the Republic of Kiribati;
 - (c) "Lead Cofinancier's Procurement Framework" means the World Bank Procurement Regulations for IPF Borrowers, July 2016 revised in November 2017 and August 2018; and
 - (d) "Project" means Parts 1, 2.1, 2.2(a), 2.2(c), 2.3(b), and 3.1 and 3.2 of the Kiribati Outer Islands Transport Infrastructure Investment Project (KOITIIP), as further described in Schedule 2 of this Project Implementation Agreement.
 - (e) "Eligible Crisis or Emergency" means an event that has caused, or is likely to imminently cause, a major adverse economic and/or social impact to the Borrower, associated with a natural or man-made crisis or disaster.

CLAUSE 2

Designation and Obligations of Lead Cofinancier

- 2.01. Pursuant to Clause 2.01 of the Procurement Framework Agreement, the World Bank is hereby designated as the Lead Cofinancier.
- 2.02. The Lead Cofinancier will ensure that the Borrower undertakes the procurement under the Project in accordance with the terms and conditions of the Procurement Framework Agreement and this Agreement, including the undertakings set out in Schedule 1 of this Agreement.
- 2.03. Pursuant to Clause 2.03 of the Procurement Framework Agreement, the Lead Cofinancier will cause the Borrower to require each bidder to submit a signed letter of acceptance, which will subsequently form integral part of the awarded contracts, in the form set forth in Appendix 2B of the Procurement Framework Agreement.

CLAUSE 3

Miscellaneous

- 3.01. For the purposes of the Project, the Cofinanciers will strictly comply with the terms and conditions set out in the Procurement Framework Agreement and this Agreement.
- 3.02. This Agreement is not intended to modify or amend the terms and conditions of the Procurement Framework Agreement.
- 3.03. This Agreement will not be amended except by agreement in writing of the World Bank and the ADB.
- 3.04. This Agreement will be executed in two counterparts, each of which will be deemed to be an original, but both of which will constitute one and the same agreement.
- 3.05. This Agreement will come into full force and effect on the date on which it is signed by the Cofinanciers and will remain in full force and effect unless and until it is terminated in accordance with Clause 6.06 of the Procurement Framework Agreement.
- 3.06. Any notice or request required or permitted to be given or made under this Agreement will be in writing in the English language and will be deemed as duly given if delivered by email (acknowledgement receipt requested), facsimile, registered or certified mail or courier service to the following addresses:

SCHEDULE 1

Project Specific Procurement Related Undertakings

- 1. The Borrower shall not award any construction or civil works contract for the Project which is jointly financed by ADB and involves environmental impacts until:
 - (a) the Borrower's Ministry of Environment, Lands and Agricultural Development has granted final approval of the environmental and social impact assessment for the relevant Project component; and
 - (b) the Borrower has incorporated the relevant provisions from the respective environmental and social management plan for the relevant Project component into the contract.
- 2. The Borrower shall not award any construction or civil works contract for the Project which is jointly financed by ADB and involves involuntary resettlement impacts, until the Borrower has prepared and submitted to ADB the final resettlement plan for the relevant Project site based on the Project's detailed design and obtained ADB's clearance of such resettlement plan.

SCHEDULE 2

Project Description

The Project is to improve the connectivity, safety and climate resilience of transport infrastructure on Abaiang, Nonouti, Beru, and Tabiteuea South and in the event of an Eligible Crisis or Emergency, to provide an immediate response to the Eligible Crisis or Emergency.

Project Components

The Project consists of the below Parts 1, 2.1, 2.2(a), 2.2(c), 2.3(b), and 3.1 and 3.2. Parts 2.2(b), 2.3(a), 3.3 and 4 will be financed by IDA only.

Part 1. Safe Inter-Island Navigation

Carrying out activities to improve the safety of inter-island navigation, including:

- (a) conducting hydrographic surveys and preparing and publishing maritime charts;
- (b) providing and installing tide gauges and current meters; and
- (c) providing contract management services to support activities under Part 1 of the Project.

Part 2. Resilient Outer Island Access Infrastructure

2.1 Improvement of Ship Safety Navigation

- (a) Designing and installing new aids to navigation and replacing existing ineffective aids to navigation in locations informed by the hydrographic surveys and maritime charts prepared under Part 1(a) of the Project.
- (b) Providing technical assistance to develop a system for maintenance of aids to navigation.

2.2 Rehabilitation of Island Access Infrastructure

Carrying out activities to construct and rehabilitate infrastructure to improve maritime access to Selected Outer Islands, as informed by the hydrographic surveys and maritime charts prepared under Part 1(a) of the Project, including:

- (a) designing and constructing a new jetty, passenger terminal, concrete ramp and associated infrastructure on the Borrower's island of Abaiang; undertaking small scale dredging in Tebikeriki, on the Borrower's island of Beru; and constructing a passenger terminal and associated infrastructure, and upgrading the seawall on Borrower's island of Beru; including preparing site assessments and safeguard documents;
- (b) constructing small multipurpose maritime facilities on Borrower's islands of Nonouti and Tabiteuea South, including a boat ramp, shelter and aids to navigation workshop; preparing site assessments and safeguard documents; and providing associated small equipment; and
- (c) providing technical assistance for the design, construction and maintenance activities under Part 2.2(b) of the Project, including conducting engineering studies, carrying out capacity development activities for the Borrower's staff, preparing safeguard documents, and conducting quality assurance audits.

2.3 Rehabilitation of Lagoon Crossings

- (a) Rehabilitating and upgrading existing causeways identified and selected in accordance with the criteria and procedures specified in the Project Operations Manual to ensure climate resilient access to Selected Outer Islands, including preparing site assessments and preparing safeguard documents, and carrying out activities related to the maintenance of the causeways.
- (b) Providing technical assistance for the design, construction and maintenance activities under Part 2.3(a) of the Project, including conducting site investigations and engineering studies, carrying out supervision of works, conducting quality assurance audits, preparing safeguard documents, and carrying out capacity development activities for staff and personnel of the Ministry of Infrastructure and Sustainable Energy ("MISE").

Part 3. Strengthening the Enabling Environment

3.1 Institutional Strengthening

Providing technical assistance to the Ministry of Information, Communications, Transport and Tourism Development ("MICTTD") and MISE to increase their capacity to implement the Project and manage transport infrastructure, including:

- (a) conducting assessments and studies, and training MICTTD staff on the development and management of a marine spatial database; and
- (b) developing a MISE capacity investment plan and providing associated training, program licenses and software.

3.2 Operational Support for the Outer Islands Implementation Unit

Providing technical and operational assistance to the Outer Islands Implementation Unit ("OIIU") on Project management and implementation, including audits, training of Project staff and personnel, supporting overall supervision of the Project, providing small equipment, reporting, monitoring and evaluation, and safeguard monitoring; and supporting gender informed activities, including citizen engagement, outreach activities, and developing employment networks designed to increase women's participation and prevent gender-based violence.

3.3 Operational Support for the Kiribati Fiduciary Services Unit

Strengthening capacity of the Kiribati Fiduciary Services Unit ("KFSU") in providing Project management and implementation support to this Project and other IBRD and/or Association financed or co-financed projects in the Borrower's territory, including audits, providing small equipment, training Project staff and personnel, reporting, and monitoring and evaluation.

Part 4. Contingent Emergency Response

Providing immediate response to an Eligible Crisis or Emergency, as needed.

- **Coercive Practice** which is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of any party to influence improperly the actions of a party.
- **Collusive Practice** which is an arrangement between two or more parties designed to achieve an improper purpose, including influencing improperly the actions of another party.
- **Abuse** which is theft, waste or improper use of assets related to ADB-related activity, either committed intentionally or through reckless disregard.
- Conflict of interest which is any situation in which a party has interests that could improperly
 influence that party's performance of official duties or responsibilities, contractual obligations, or
 compliance with applicable laws and regulations.
- Obstructive Practice which includes (a) deliberately destroying, falsifying, altering or concealing of evidence material to an ADB investigation; (b) making false statements to investigators in order to materially impede an ADB investigation; (c) failing to comply with requests to provide information, documents, or records in connection with an ADB investigation; (d) threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the

investigation or from pursuing the investigation; or (e) materially impeding ADB's contractual rights of audit or inspection or access to information.
