***Re: Co-financing of Productive Safety Net Project IV
(TF Grant No. TF0A1426)
Amendment to the Grant Agreement***

Reference is made to the Grant Agreement for the above-referenced project dated December 4, 2015 (as amended), between the Federal Democratic Republic of Ethiopia ("Recipient") and the International Development Association ("World Bank"), acting as administrator of the Ethiopia Productive Safety Net Project IV Multi-Donor Trust Fund (the "Grant Agreement").

Pursuant to recent discussions between the Recipient and the World Bank, the parties agree to the following amendments to the Grant Agreement:

1. Section 3.01 of the Grant Agreement is deleted in its entirety and replaced by the following:

"3.01. The World Bank agrees to extend to the Recipient, on the terms and conditions set forth or referred to in this Agreement, a grant in an amount equal to fifty-six million six hundred twenty thousand two hundred and thirteen United States Dollars and eighty-three cents (\$56,620,213.83) ("Grant") to assist in financing the Project."

2. The table under Section IV.A.2 of Schedule 2 to the Grant Agreement is deleted in its entirety and replaced by the following:


