FINANCING AGREEMENT

AGREEMENT dated June 10, 2011, entered into between the REPUBLIC OF SENEGAL ("Recipient") and INTERNATIONAL DEVELOPMENT ASSOCIATION ("Association") for the purpose of providing financing in support of the Program (as defined in the Appendix to this Agreement). The Association has decided to provide this financing on the basis, inter alia, of: (a) the actions which the Recipient has already taken under the Program and which are described in Section I of Schedule 1 to this Agreement, and (b) the Recipient's maintenance of an appropriate macroeconomic policy framework. The Recipient and the Association therefore hereby agree as follows:

ARTICLE I — GENERAL CONDITIONS; DEFINITIONS

- 1.01. The General Conditions (as defined in the Appendix to this Agreement) constitute an integral part of this Agreement.
- 1.02. Unless the context requires otherwise, the capitalized terms used in this Agreement have the meanings ascribed to them in the General Conditions or in the Appendix to this Agreement.

ARTICLE II — FINANCING

- 2.01. The Association agrees to extend to the Recipient, on the terms and conditions set forth or referred to in this Agreement, a credit in an amount equivalent to twenty-six million five hundred thousand Special Drawing Rights (SDR 26,500,000) (variously, "Credit" and "Financing").
- 2.02. The Recipient may withdraw the proceeds of the Financing in support of the Program in accordance with Section II of Schedule 1 to this Agreement.
- 2.03. The Maximum Commitment Charge Rate payable by the Recipient on the Unwithdrawn Financing Balance shall be one-half of one percent (1/2 of 1%) per annum.
- 2.04. The Service Charge payable by the Recipient on the Withdrawn Credit Balance shall be equal to three-fourths of one percent (3/4 of 1%) per annum.
- 2.05. The Payment Dates are June 15 and December 15 in each year.
- 2.06. The principal amount of the Credit shall be repaid in accordance with repayment schedule set forth in Schedule 2 to this Agreement.
- 2.07. The Payment Currency is EURO.

ARTICLE III — PROGRAM

- 3.01. The Recipient declares its commitment to the Program and its implementation. To this end:
 - (a) the Recipient and the Association shall from time to time, at the request of either party, exchange views on the Recipient's macroeconomic policy framework and the progress achieved in carrying out the Program;
 - (b) prior to each such exchange of views, the Recipient shall furnish to the Association for its review and comment a report on the progress achieved in carrying out the Program, in such detail as the Association shall reasonably request; and
 - (c) without limitation upon the provisions of paragraphs (a) and (b) of this Section, the Recipient shall promptly inform the Association of any situation that would have the effect of materially reversing the objectives of the Program or any action taken under the Program including any action specified in Section I of Schedule 1 to this Agreement.

ARTICLE IV — REMEDIES OF THE ASSOCIATION

- 4.01. The Additional Event of Suspension consists of the following:
 - (a) A situation has arisen which shall make it improbable that the Program, or a significant part of it, will be carried out.

ARTICLE V — EFFECTIVENESS; TERMINATION

- 5.01. The Additional Condition of Effectiveness consists of the following:
 - (a) The Association is satisfied with the progress achieved by the Recipient in carrying out the Program and with the adequacy of the Recipient's macroeconomic policy framework.
- 5.02. The Effectiveness Deadline is the date ninety (90) days after the date of this Agreement.

ARTICLE VI — REPRESENTATIVE; ADDRESSES

- 6.01. The Recipient's Representative is its Minister in charge of finance

SCHEDULE 1

Program Actions; Availability of Financing Proceeds

Section I. Actions under the Program

A. <u>Actions Taken Under the Program</u>. The actions taken by the Recipient under the Program include the following:

Private Sector Development

• Issuance of a decree by the President of the Recipient doubling the road user charge transferred to the FERA from the initial levels of CFA F 35.45, CFA F 31.95, and CFA F 15.95 per liter respectively for diesel, premium gasoline, and regular gasoline.

Human Development

- Satisfactory progress made in strengthening human resource management in the
 education sector, as evidenced by the adoption by the HR department of the Ministry of
 the Recipient in charge of primary education of an identification system using an
 identification number for all contractual teachers consistent with civil service
 identifications and the effective integration of the Volunteers Project Unit into the HR
 directorate of the Ministry of Education.
- Satisfactory progress made in the implementation of the Recipient's hospital policy, as
 evidenced by the preparation and signing by the Ministry of the Recipient in charge of
 health of performance contracts with at least five Public Hospitals consistent with the
 decrees fixing the financial regime and describing the financing arrangements and
 oversight of the Public Hospitals.
- Adoption and initiation of implementation of a medium-term plan for sustainable financing of the Nutrition Reinforcement Program.

Mitigating Vulnerabilities

• Establishment by the Ministry of the Recipient in charge of fisheries of an industrial fishing vessel registry and artisanal vessel matriculation database accessible to the public on-line.

Public Governance

- Improvement of budget reporting to the public by presenting and publishing the 2011 budget envelopes for the sectors of education, health, justice and decentralization using the spatial code at, at least, the departmental level as evidenced by detailed SIGFIP reports.
- Adoption of a new law governing land ownership that modernizes and clarifies the overall legal framework for land ownership.

• Adoption by the Council of Ministers of the Recipient of amendments to the Statistics Law that mandate a more open access by users to anonymised primary data.

Section II. <u>Availability of Financing Proceeds</u>

- **A. General.** The Recipient may withdraw the proceeds of the Financing in accordance with the provisions of this Section and such additional instructions as the Association may specify by notice to the Recipient.
- **B.** Allocation of Financing Amounts. The Financing (except for amounts required to repay the Preparation Advance) is allocated in a single withdrawal tranche, from which the Recipient may make withdrawals of the Financing. The allocation of the amounts of the Financing to this end is set out in the table below:

C. Withdrawal Tranche Release Conditions.

1. No withdrawal shall be made of the Single Withdrawal Tranche unless the Association is satisfied: (a) with the Program being carried out by the Recipient, and (b) with the appropriateness of the Recipient's macroeconomic policy framework.

D. Deposits of Financing Amounts. Except as the Association may otherwise agree:

- 1. all withdrawals from the Financing Account shall be deposited by the Association into an account designated by the Recipient ("Dedicated Account") and acceptable to the Association; and
- 2. the Recipient shall ensure that upon each deposit of an amount of the Financing into this account, an equivalent amount is accounted for in the Recipient's budget management system, in a manner acceptable to the Association.
- **Excluded Expenditures**. The Recipient undertakes that the proceeds of the Financing shall not be used to finance Excluded Expenditures. If the Association determines at any time that an amount of the Financing was used to make a payment for an Excluded Expenditure, the Recipient shall, promptly upon notice from the Association, refund an amount equal to the amount of such payment to the Association. Amounts refunded to the Association upon such request shall be cancelled.

- **F. Audit.** Upon the Association's request, the Recipient shall:
- 1. have the Dedicated Account audited by independent auditors acceptable to the Association, in accordance with consistently applied auditing standards acceptable to the Association;
- 2. furnish to the Association as soon as available, but in any case not later than four months after the date of the Association's request for such audit, a certified copy of the report of such audit, of such scope and in such detail as the Association shall reasonably request; and
- 3. furnish to the Association such other information concerning the Dedicated Account and its audit as the Association shall reasonably request.
- **G.** Closing Date. The Closing Date is March 31, 2012.

APPENDIX

Section I. Definitions

- 1. "CFAF" means Franc de la Communauté financière Africaine, the currency of the Recipient.
- 2. "Excluded Expenditure" means any expenditure:
 - (a) for goods or services supplied under a contract which any national or international financing institution or agency other than the Association or the Bank has financed or agreed to finance, or which the Association or the Bank has financed or agreed to finance under another credit, grant or loan;
 - (b) for goods included in the following groups or sub-groups of the Standard International Trade Classification, Revision 3 (SITC, Rev.3), published by the United Nations in Statistical Papers, Series M, No. 34/Rev.3 (1986) (the SITC), or any successor groups or subgroups under future revisions to the SITC, as designated by the Association by notice to the Recipient:

- (c) for goods intended for a military or paramilitary purpose or for luxury consumption;
- (d) for environmentally hazardous goods, the manufacture, use or import of which is prohibited under the laws of the Recipient or international agreements to which the Recipient is a party[, and any other goods designated as environmentally hazardous by agreement between the Recipient and the Association]¹);
- (e) on account of any payment prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations; and
- (f) with respect to which the Association determines that corrupt, fraudulent, collusive or coercive practices were engaged in by representatives of the Recipient or other recipient of the Financing proceeds, without the Recipient (or other such recipient) having taken timely and appropriate action satisfactory to the Association to address such practices when they occur.
- 3. "FERA" means *Fonds d'Entretien Routier Autonome*, the Recipient's Autonomous Road Maintenance Fund.
- 4. "General Conditions" means the "International Development Association General Conditions for Credits and Grants", dated July 31, 2010 with the modifications set forth in Section II of this Appendix.
- 5. "HR" means human resources.
- 6. "Nutrition Reinforcement Program" (known in French as *Programme de Renforcement de la Nutrition*) means the Recipient's program designed to improve the nutritional status of the most vulnerable groups of the Recipient's population and set forth or referred to in the letter dated January 25, 2002 and updated in June 2006 from the Recipient to the Association.
- 7. "Preparation Advance" means the advance referred to in Section 2.05 of the General Conditions (renumbered as such pursuant to paragraph 2 of Section II below), granted by the Association to the Recipient pursuant to the letter agreement signed on behalf of the Association and on behalf of the Recipient on June 24, 2010.
- 8. "Program" means the program of actions, objectives and policies designed to promote growth and achieve sustainable reductions in poverty and set forth or referred to in the letter dated April 15, 2011 from the Recipient to the Association declaring the Recipient's commitment to the execution of the Program, and requesting assistance from the Association in support of the Program during its execution.

¹ In certain operations, the Association agrees with the Recipient on materials excluded from financing on environmental grounds (e.g., exclusion of specified pesticides). The bracketed clause is to be included only if agreement between the Recipient and the Association on a list of goods designated as environmentally hazardous for purposes of this Financing has been reached and recorded in the agreed minutes of negotiations or a supplemental letter

- 9. "Public Hospitals" means *Etablissements Publics Hospitaliers*, the Recipient's public hospitals established and functioning pursuant to the Recipient's Law 98-08, dated February 12, 1998.
- 10. "SIGFIP" means *Système Intégré de Gestion des Finances Publiques*, one of the Recipient's budget management information systems.
- 11. "Single Withdrawal Tranche" means the amount of the Financing allocated to the category entitled "Single Withdrawal Tranche" in the table set forth in Part B of Section II of Schedule 1 to this Agreement.
- 12. "Statistics Law" means the Recipient's Law No.2004-21, dated July 21, 2004 which organized the statistical activities.
- 13. "Volunteers Project Unit" means the Recipient's *Projet des Volontaires de l'Education*set up through *Arrêté* No 000732, dated February 19, 2003 issued by the Minister in charge of primary education.

Section II. Modifications to the General Conditions

The modifications to the General Conditions are as follows:

- 1. The last sentence of paragraph (a) of Section 2.03 (relating to Applications for Withdrawal) is deleted in its entirety.
- 2. Sections 2.04 (*Designated Accounts*) and 2.05 (*Eligible Expenditures*) are deleted in their entirety, and the remaining Sections in Article II are renumbered accordingly.
- 3. Sections 4.01 (*Project Execution Generally*), and 4.09 (*Financial Management*; *Financial Statements*; *Audits*) are deleted in their entirety, and the remaining Sections in Article IV are renumbered accordingly.
- 4. Paragraph (a) of Section 4.05 (renumbered as such pursuant to paragraph 3 above and relating to *Use of Goods, Works and Services*) is deleted in its entirety.
- 5. Paragraph (c) of Section 4.06 (renumbered as such pursuant to paragraph 3 above) is modified to read as follows:

"Section 4.06. Plans; Documents; Records

- ... (c) The Recipient shall retain all records (contracts, orders, invoices, bills, receipts and other documents) evidencing expenditures under the Financing until two years after the Closing Date. The Recipient shall enable the Association's representatives to examine such records."
- 6. Section 4.07 (renumbered as such pursuant to paragraph 3 above) is modified to read as follows:

"Section 4.07. Program Monitoring and Evaluation

- ... (c) The Recipient shall prepare, or cause to be prepared, and furnish to the Association not later than six months after the Closing Date, a report of such scope and in such detail as the Association shall reasonably request, on the execution of the Program, the performance by the Recipient and the Association of their respective obligations under the Legal Agreements and the accomplishment of the purposes of the Financing."
- 7. The following terms and definitions set forth in the Appendix are modified or deleted as follows, and the following new terms and definitions are added in alphabetical order to the Appendix as follows, with the terms being renumbered accordingly:
 - (a) The definition of the term "Eligible Expenditure" is modified to read as follows:
 - "Eligible Expenditure' means any use to which the Financing is put in support of the Program, other than to finance expenditures excluded pursuant to the Financing Agreement."
 - (b) The term "Financial Statements" and its definition as set forth in the Appendix are deleted in their entirety.
 - (c) The term "Project" is modified to read "Program" and its definition is modified to read as follows:
 - "'Program' means the program referred to in the Financing Agreement in support of which the Financing is made." All references to "Project" throughout these General Conditions are deemed to be references to "Program".
