**ADDENDUM no. 3**

**TO THE AGREEMENT FOR ADVISORY SERVICES  
ON ASSISTANCE TO THE MINISTRY OF NATIONAL EDUCATION FOR  
REDUCING EARLY SCHOOL LEAVING**

This addendum is made the 12<sup>th</sup> day of June 2015, between the MINISTRY OF EDUCATION AND SCIENTIFIC RESEARCH OF ROMANIA (formerly the Ministry of National Education of Romania) (the "Recipient") and the INTERNATIONAL BANK FOR RECONSTRUCTION AND DEVELOPMENT (the "Bank") (jointly referred to as "the Parties") to the Agreement for Advisory Services on Assistance to the Ministry of National Education for Reducing Early School Leaving between the Parties dated June 12, 2011 (the Agreement), as amended on February 6, 2014 and December 15, 2014.

The Parties agree to amend the Agreement as follows (revisions are included in *bold and italics*):

1. Throughout the Agreement the references to "Ministry of National Education" are hereby replaced by "Ministry of Education and Scientific Research", and the references to "MoNE" are hereby replaced by "MESR".
2. The table in paragraph 11(b) of the Agreement is hereby amended to read in its entirety as follows:

3. Paragraph 12(a) of the Agreement is hereby amended to read in its entirety as follows:  

***"12. Expiration and Termination.*** (a) This Agreement shall expire on the day falling ***twenty eight (28)*** months after the Effective Date unless it shall earlier be renewed with mutual agreement of the Recipient and the Bank."
4. The table in Section 1 of Schedule 1 to the Agreement is modified to read as follows:
