***Supplemental Contribution Amendment to the Administration Agreement between the Kingdom of Netherlands and the International Bank for Reconstruction and Development and the International Development Association concerning the Multi-Donor Trust Fund for Low-Income Countries for the Financial Sector Reform and Strengthening Initiative (TF No. 070711)***

Dear Mr. Raes:

1. We refer to the Administration Agreement between Kingdom of Netherlands, as represented by the Minister of Development Cooperation (the "Donor") and the International Bank for Reconstruction and Development (IBRD) and the International Development Association (IDA), (collectively, the "Bank") regarding the Multi-Donor Trust Fund for Low-Income Countries for the Financial Sector Reform and Strengthening Initiative (TF 070711) (the "Trust Fund") effective December 21, 2007, as amended (the "Administration Agreement").
2. We are pleased to acknowledge, on behalf of the Bank, the intention of the Donor, to make a supplemental contribution to the Trust Fund in the amount of twenty eight million and five hundred thousand United States Dollars (USD 28,500,000) (the "Supplemental Contribution").
3. The Donor shall deposit the Supplemental Contribution into such bank account designated by the Bank in installments in accordance with the following schedule:
  - (a) promptly following countersignature of this amendment by the Donor and submission of a payment request by the Bank, seven million and five hundred thousand United States Dollars (USD 7,500,000);
  - (b) on or before November 30, 2013, and upon submission of a payment request by the Bank, seven million and five hundred thousand United States Dollars (USD 7,500,000);
  - (c) on or before November 30, 2014, and upon submission of a payment request by the Bank, six million and five hundred thousand United States Dollars (USD 6,500,000)
  - (d) on or before December 31, 2014, and upon submission of a payment request by the Bank, six million and five hundred thousand United States Dollars (USD 7,000,000).

The Supplemental Contribution is being provided in installments on the basis of financial needs of the Trust Fund, such that if the speed of the implementation of the activities to be financed by the Trust Fund makes it necessary either to bring installments forward or to delay them, the installment schedule shall be amended as agreed by the Bank and the Donor.


4 All other terms of the Administration Agreement shall remain the same and shall apply to the Supplemental Contribution.

5 The Bank will disclose this amendment and related information on this Trust Fund in accordance with the World Bank Policy on Access to Information. By entering into this amendment, the Donor consents to disclosure of this amendment and related information on this Trust Fund.

6 We propose that this letter shall constitute an amendment to the Administration Agreement between the Bank and the Donor. Please confirm your acceptance to the foregoing, on behalf of the Donor, by signing and dating the two originals, retaining one original for your records and returning the other original to the Bank. Upon receipt by the Bank of the original countersigned by you, this amendment will become effective as of the date of the countersignature.


