Amendment #7 to the Agreement between the Bill & Melinda Gates Foundation and the International Development Association concerning the Global Program to Eradicate Poliomyelitis (TF050775; Bill & Melinda Gates Foundation Grant #4890)

Dear Mr. Baeza:

1. I refer to the Letter of Agreement between the International Development Association ("IDA") and the Bill & Melinda Gates Foundation (the "Foundation") dated December 3, 2002 (the "Agreement") as amended, concerning a grant provided by the Foundation for the purpose of financing the Global Program to Eradicate Poliomyelitis (TF050775) ("the Trust Fund").
2. Following recent discussions between the Foundation and the Bank on the use of the funds of the Trust Fund, the Foundation is pleased to make a supplemental grant to the Trust Fund in the amount of eighteen million nine hundred and forty thousand dollars (US\$18,940,000) (Additional Contribution). With this additional contribution the total contribution amount provided by the Foundation to this Trust Fund will now aggregate to one hundred and two million four hundred forty thousand dollars (US\$102,440,000.00) (the "Grant").
3. The Foundation shall deposit the Supplemental Contribution into such bank account designated by the Bank promptly following countersignature of this Amendment Letter by the Foundation and submission of a payment request by the Bank. When making such deposit, the Foundation shall instruct its bank to include in its payment details information (remittance advice) field of its SWIFT payment message, information indicating: the amount paid, that the payment is made by the Foundation for TF050775 (Global Program to Eradicate Poliomyelitis), and the date of the deposit. In addition, the Foundation shall provide a copy of the Foundation's deposit instruction to the Bank's Accounting Trust Funds Division by e-mail sent to tfremittanceadvice@worldbank.org or by fax sent to (202) 614-1315.
4. It is understood that the Bank will disclose this Agreement and related information on this Trust Fund in accordance with the World Bank Policy on Access to Information. By entering into this Agreement, the Foundation consents to disclosure of this Agreement and related information on this Trust Fund.
5. Except as specifically amended hereby, all other terms and conditions of the Agreement remain in full force and effect.


