


Amendment No. 1 to the Amended and Restated Administration Agreement between the Republic of Italy, acting through its Ministry of Foreign Affairs and International Cooperation, and the International Bank for Reconstruction and Development and the International Development Association regarding the Integrated Household and Agricultural Surveys in Low and Middle-Income Countries Multi-Donor Trust Fund (Trust Fund No. 072496)

1. Reference is made to the Amended and Restated Administration Agreement between the Republic of Italy, acting through its Ministry of Foreign Affairs and International Cooperation (the “Donor”) and the International Bank for Reconstruction and Development and the International Development Association (collectively, the “Bank” and together with the Donor, the “Parties” and each a “Party”, regarding the Integrated Household and Agricultural Surveys in Low and Middle-Income Countries Multi-Donor Trust Fund (Trust Fund No. 072496) effective as of August 3, 2020 (the “Administration Agreement”).
2. The Bank acknowledges that the Donor, through the Italian Agency for Development Cooperation (“AICS”), agrees to provide an additional contribution in the amount of four hundred eighty-one thousand nine hundred and fifty Euros (EUR 481,950) (the “Contribution”) for the Trust Fund in accordance with the terms of the Administration Agreement.
3. The Donor shall deposit the Contribution promptly following countersignature of this Amendment in the full amount and currency specified in paragraph 2 above into such bank account designated by the Bank upon submission of a payment request by the Bank.
4. When making a deposit, the Donor shall instruct its bank to include in its deposit details information (remittance advice) field of its SWIFT deposit message, information indicating: the amount deposited, that the deposit is made by the Donor for Trust Fund No. 072496 (the Integrated Household and Agricultural Surveys in Low and Middle-Income Countries Multi-Donor Trust Fund), and the date of the deposit (the “Deposit Instructions”). In addition, the Donor shall provide a copy of the Deposit Instructions to the Bank’s Accounting Trust Funds Division by e-mail sent to tfermitadvice@worldbank.org or by fax sent to (202) 614-1315.
5. All other terms of the Administration Agreement shall remain the same.
