#### **Procurement Guidelines provided in the TCIP Financing Agreement**

#### A. General

- 1. Goods, Works, and Telecom Services. All goods, works and Telecom Services required for the Project and to be financed out of the proceeds of the Financing shall be procured in accordance with the requirements set forth or referred to in Section I of the Procurement Guidelines, and with the provisions of this Section.
- 2. Consultants' Services. All consultants' services required for the Project and to be financed out of the proceeds of the Financing shall be procured in accordance with the requirements set forth or referred to in Sections I and IV of the Consultant Guidelines, and with the provisions of this Section.
- **Definitions.** The capitalized terms used below in this Section to describe particular procurement methods or methods of review by the Association of particular contracts, refer to the corresponding method described in the Procurement Guidelines, or Consultant Guidelines, as the case may be.

## B. Particular Methods of Procurement of Goods, Works, and Telecom Services

- 1. **International Competitive Bidding.** Except as otherwise provided in paragraph 2 below, goods, and Telecom Services shall be procured under contracts awarded on the basis of International Competitive Bidding.
- 2. **Other Methods of Procurement of Goods, Works and Telecom Services.** The following table specifies the methods of procurement, other than International Competitive Bidding, which may be used for goods, works and Telecom Services. The Procurement Plan shall specify the circumstances under which such methods may be used:

# Additional Guidelines regarding the Grant Facilities

The ICT Board shall ensure that the beneficiaries of the grant facilities under Part 1(c), 2(c) and 2(d) of the Project are selected in accordance with qualifying criteria, procedures, and on terms and conditions as shall be included in the Grants Operational Manual.

For any grant under Part 1(c), 2(c) and 2(d) of the Project, no disbursement will be made unless the disbursement and governance mechanisms are in place and satisfactory to the World Bank and the grants concerned shall have been made according to the procedures set in the Grants Operational Manual

"Grants Operational Manual" means the manual describing eligible activities and qualifications for recipients, other policies and procedures for activities to be carried out under Part 1(c), 2(c), 2(d) of the Project, as adopted and approved by the ICT Board, and as the same shall be amended from time to time acceptable to the World Bank.
